**REASSIGNMENT OF THE UNITED STATES ARMY CENTER OF MILITARY HISTORY AS A  
SUBORDINATE ORGANIZATION TO THE  
UNITED STATES ARMY TRAINING AND DOCTRINE COMMAND**

1. Effective 01 October 2019, the United States Army Center of Military History (CMH) (UIC: W3YUAA), a Field Operating Agency under the Administrative Assistant to the Secretary of the Army (excluding its subordinate element, The Institute of Heraldry (TIOH)), is transferred to the United States Army Training and Doctrine Command (TRADOC) (UIC: W3YTAA) as a subordinate organization reporting directly to the Deputy Commanding General/Chief of Staff. This reassignment includes transfer of authorities, missions, personnel, facilities, equipment, property, funding, and resources. TIOH (paragraph 700 through 730 of UIC: W3YUAA) will remain as a subordinate element of the Administrative Assistant to the Secretary of the Army in U.S. Army Resources and Programs Agency (RPA) (UIC: W2TZAA). This includes missions, personnel, equipment, funding, and resources.

2. All personnel, equipment, and other resources assigned or allocated to CMH (minus TIOH) and its components are transferred and reassigned under the authority, direction, and control of the Commanding General, TRADOC. The Commanding General, TRADOC will exercise all authority, direction, and control over the CMH, to include prescribing CMH missions, functions, and responsibilities.

3. The mission of CMH is to—

*a.* Formulate and execute the Army Historical Program; oversee the Army Museum Enterprise, to include the National Museum of the United States Army (NMUSA) and the Army Artifact Collection.


*b.* Prepare and publish the official history of the United States Army and associated historical products needed by the service, to include historical coverage of and support to the Headquarters, Department of the Army.

*c.* Formulate the historical background and precedent required for the development of military plans, policies, doctrine, and techniques; collect and maintain repositories for the preservation of historical documents, art, and artifacts relating to the United States Army.

*d.* Maintain the lineage and honors and unit designation systems that apply to all Army organizations.

*e.* Coordinate with and assist public and private agencies in all matters regarding Army history.
