SUBJECT: Army Directive 2020-07 (Army National Guard Military Morale, Welfare, and Recreation Programs and Nonappropriated Fund Instrumentalities)

## 1. References.

- a. Department of Defense Instruction 1015.15 (Establishment, Management, and Control of Nonappropriated Fund Instrumentalities and Financial Management of Supporting Resources), 31 October 2007, incorporating Change 1, effective 20 March 2008
- b. Army Regulation (AR) 215–1 (Military Morale, Welfare, and Recreation Programs and Nonappropriated Fund Instrumentalities), 24 September 2010
- 2. Purpose. This directive updates policy in AR 215–1.
- 3. Applicability. This directive applies to the Regular Army, Army National Guard/Army National Guard of the United States, and United States Army Reserve.

#### 4. Policy.

- a. Effective immediately, Morale, Welfare and Recreation (MWR) programs and nonappropriated fund instrumentalities (NAFIs) established in accordance with AR 215–1 are authorized for the Army National Guard/Army National Guard of the United States. The Army MWR fund will be designated as successor-in-interest for Army National Guard/Army National Guard of the United States MWR NAFIs. The U.S. Army Nonappropriated Fund Risk Management Program applies to Army National Guard/Army National Guard of the United States MWR programs and NAFIs established pursuant to this policy.
- b. The Commanding General (CG), U.S. Army Installation Management Command (IMCOM) will review for suitability and establish, maintain, and disestablish revenue-generating MWR programs and NAFIs within the Army National Guard/Army National Guard of the United States pursuant to AR 215–1, paragraph 3-10. This authority may be delegated to the Director, IMCOM G9, Family and Morale, Welfare, and Recreation (formerly Commander, FMWRC). Once an Army National Guard/Army National Guard of the United States NAFI is established, the Director, IMCOM G9 will assign a standard NAFI identification number in accordance with AR 215–1, appendix F.

- c. The Chief, National Guard Bureau will—
- (1) submit requests to establish Army National Guard/Army National Guard of the United States NAFIs through the Director, IMCOM G9 to the CG, IMCOM
- (2) publish implementing guidance and develop uniform procedures for NAFIs throughout the Army National Guard/Army National Guard of the United States within 180 days from the date of this directive
- 5. Proponent. The Deputy Chief of Staff, G-9 is the proponent for this policy and, under the policy oversight of the Assistant Secretary of the Army for Financial Management and Comptroller, will incorporate the provisions of this directive into AR 215–1 within 2 years.
- 6. Duration. This directive is rescinded on publication of the revised regulation.
