SUBJECT: AD 2022-11 (Designation of Deputy for Medical Systems)

1. References.

- a. Title 10, U.S. Code, section 7013
- b. Army Regulation (AR) 70–1 (Army Acquisition Policy), 10 August 2018, (hereby partially superseded)
- c. Headquarters, Department of the Army General Orders 2019–38 (Reassignment and Redesignation of U.S. Army Medical Research and Materiel Command and Establishment of the U.S. Army Medical Logistics Command), 5 November 2019

2. Purpose. This directive partially supersedes AR 70–1 and redesignates the Deputy for Medical Systems for the Assistant Secretary of the Army for Acquisition, Logistics, and Technology (ASA (ALT)).

3. Applicability. The provisions of this directive apply to the Regular Army, Army National Guard/Army National Guard of the United States, and U.S. Army Reserve.

4. Policy.


a. Paragraph 1–4m(3) of AR 70–1 is hereby superseded. The Commanding General, United States Army Medical Research and Development Command (CG, USAMRDC) is hereby designated as the Deputy for Medical Systems for the ASA (ALT).

b. The Deputy for Medical Systems performs the functions assigned to the former United States Army Medical Research and Materiel Command (AMRMC) as prescribed in AR 70–1.

5. The ASA (ALT) is the proponent for this policy, responsible for incorporating the provisions of this directive into AR 70–1 within 2 years of the date of this directive.

6. Duration. This directive is rescinded on publication of the revised regulation.
