THIS ALARACT MESSAGE HAS BEEN TRANSMITTED BY JSP ON BEHALF OF HQDA, OTSG

- 1. (U) SITUATION. ALL HOSPITAL CENTER UNITS ARE TO SELF-CONVERT LEGACY WATER DISTRIBUTION AND WASTE WATER MANAGEMENT SYSTEM (WDWWMS) LINE ITEM NUMBERS (LINS) TO NEW LINS IN ACCORDANCE WITH FY25 COMMAND PLAN DOCUMENTATION CHANGES.
- 2. (U) BACKGROUND. IN 2016, HEADQUARTERS, DEPARTMENT OF THE ARMY (HQDA) APPROVED THE FORCE DESIGN UPDATE (FDU) CONVERTING HOSPITAL STRUCTURE TO THE HOSPITAL CENTER AND FIELD HOSPITAL CONSTRUCT. THIS FDU APPROVAL WAS WITHOUT A FINAL MATERIEL SOLUTION TO SUPPORT WATER DISTRIBUTION AND WASTE WATER MANAGEMENT REQUIREMENTS SPECIFIC TO EACH HOSPITAL AUGMENTATION DETACHMENT. UNTIL HQDA IDENTIFIED A NEW MATERIEL SOLUTION. THE LEGACY WDWWMS REMAINED AUTHORIZED TO THE HEADQUARTERS AND HEADQUARTERS DETACHMENT (HHD), HOSPITAL CENTER AND FIELD HOSPITAL UNITS PROVIDING THE REQUIRED WDWWMS CAPABILITY. AS PART OF THE UNIT CONVERSION PROCESS, THE U.S. ARMY MEDICAL MATERIEL DEVELOPMENT ACTIVITY (USAMMDA) PROCURED AND FIELDED TO ALL HOSPITAL CENTERS ADDITIONAL WDWWMS COMPONENTS REQUIRED TO SUPPORT ALL HOSPITAL AUGMENTATION DETACHMENTS. AT TIME OF CONVERSION. USAMMDA INSTRUCTED UNITS TO NOT DISCARD OR TURN IN ANY WDWWMS EQUIPMENT. IN 2020. HQDA COMPLETED REQUIREMENTS DETERMINATION AND MATERIEL ACQUISITION PROCESSES CREATING SIX NEW WDWWMS SETS. KITS. AND OUTFITS (SKO) WITH THESE ISSUES SENT TO THE HOSPITAL AUGMENTATION DETACHMENTS. IN NOVEMBER 2023, HQDA MADE ADMINISTRATIVE CHANGES TO FY24 MODIFIED TABLE OF ORGANIZATION AND EQUIPMENT DOCUMENTATION TO ADD AUTHORIZATIONS FOR THE NEW WDWWMS SKO AND REMOVE AUTHORIZATIONS FOR THE LEGACY WDWWMS SKO ACROSS THE ENTIRE ARMY.
- 3. (U) PURPOSE. THIS MESSAGE NOTIFIES UNITS OF THE PROCESS TO SELF-CONVERT ALL WDWWMS AND REQUIRED PROPERTY BOOK ACTIONS SUPPORTING THE CONVERSION.
