2. (U) PURPOSE: TO INFORM COMMANDERS OF THE PROGRAM NAME CHANGE
AND TO PROVIDE TRAINING OPPORTUNITIES IN SUPPORT OF WATER
PRODUCTION SYSTEMS. FORCES COMMAND AND ARMY RESERVE COMMAND
HAS ESTABLISHED AND MAINTAINS A COLLECTIVE UNIT LEVEL TACTICAL
TRAINING FACILITY AT FORT STORY, VA, INTEGRATING A JOINT FORCES
LIQUID LOGISTICS SUSTAINMENT READINESS APPROACH.

3. (U) MISSION: THE FORSCOM LOGISTICS TRAINING CLUSTER (FLTC) HAS
CHANGED ITS NAME TO WATER PRODUCTION SUSTAINMENT TRAINING
(WPST). WPST WILL CONTINUE TO PROVIDE COMPREHENSIVE AND
ADVANCED WATER AND MAINTENANCE TRAINING FOR ARMY AND JOINT
FORCES COVERING WATER OPERATIONS UNDER ALL CONDITIONS. THE
FORSCOM WPST DELIVERS THE MOST CRITICAL, IN DEPTH, REALISTIC, AND
DETAILED MILITARY REVERSE OSMOSIS WATER PURIFICATION UNIT (ROWPU)
TRAINING SERVICES AVAILABLE TO LAND BASED FORCES WITHIN THE
MILITARY. WPST IS CAPABLE OF PROVIDING SALT OR FRESH WATER
PURIFICATION TRAINING AT FORT STORY, VA. THIS LOCATION PROVIDES A
FULL SPECTRUM OF TRAINING ON ALL U.S. ARMY WATER PRODUCTION
EQUIPMENT, QUALITY ASSURANCE, AND STORAGE AND DISTRIBUTION
EQUIPMENT.

4. (U) THE TRAINING COURSES THAT ARE PROVIDED AT THE WPST ARE ON
THE FOLLOWING SYSTEMS: THE 3000-GALLON PER HOUR (GPH) REVERSE

OSMOSIS WATER PURIFICATION UNIT (ROWPU), TACTICAL WATER PURIFICATION SYSTEM (TWPS), LIGHTWEIGHT WATER PURIFIER (LWP) TACTICAL WATER DISTRIBUTION SYSTEM (TWDS), WATER STORAGE AND DISTRIBUTION SYSTEM (WSDS), AND LOAD HANDLING SYSTEM COMPATIBLE WATER TANK RACK (HIPPO). WE ALSO OFFER 91J WATER EQUIPMENT MAINTAINERS, AND 92W MAINTENANCE COURSE REFRESHER TRAINING. SOME OF THE COURSES INCLUDE A BASIC (ONE WEEK) COURSE AND OPPORTUNITIES FOR MORE ADVANCED (TWO WEEK) COURSE.

5. (U) RESIDENT COURSES ARE TAUGHT AT FORT STORY, VA. SOME CAN BE TAUGHT AT THE UNIT'S CHOSEN LOCATION THROUGH MOBILE TECHNICAL TRAINING (MTT) TEAMS. THE NECESSARY EQUIPMENT MUST BE FULLY MISSION CAPABLE AND AVAILABLE AT THE UNIT'S LOCATION. WPST ALSO PROVIDES MOBILE MAINTENANCE TRAINING (MMT). MTTs AND MMTs ARE SUBJECT TO LIMITED AVAILABILITY AND WILL BE PROVIDED ON A FIRST-COME FIRST-SERVE BASIS.

6. (U) BILLETING IS PROVIDED AT NO COST TO THE UNIT. STUDENTS WILL NEED TO BRING THEIR OWN LINENS AS THEY ARE NOT SUPPLIED.

7. (U) TRANSPORTATION FOR STUDENTS TO AND FROM THE NORFOLK AIRPORT WILL BE PROVIDED BY THE WPST STAFF AT NO COST. UNITS CAN APPROVE ALTERNATE HOUSING AND TRANSPORTATION FOR THEIR SOLDIERS, BUT IT WILL BE AT THE UNIT EXPENSE.

8. (U) MEALS ARE PROVIDED AT NO COST TO THE UNIT THROUGH THE NAVY GALLEY DINNING FACILITY LOCATED AT JOINT EXPEDITIONARY BASE LITTLE CREEK-FORT STORY.

9. (U) TRAINING IS PROVIDED AT NO COST HOWEVER, THE ONLY COST TO THE UNIT IS THE TRAVEL FROM THE UNIT LOCATION TO WPST.
