- 2. (U) PURPOSE. TO INFORM COMMANDERS OF THE PROGRAM NAME CHANGE AND TO ANNOUNCE TRAINING OPPORTUNITIES IN SUPPORT OF PETROLEUM OPERATIONS. FORCES COMMAND AND ARMY RESERVE COMMAND HAVE ESTABLISHED AND MAINTAIN A COLLECTIVE UNIT LEVEL TACTICAL TRAINING FACILITY AT FORT BARFOOT, VA, INTEGRATING A JOINT FORCES LIQUID LOGISTICS SUSTAINMENT READINESS APPROACH.
- 3. (U) MISSION. THE FORSCOM PETROLEUM TRAINING MODULE HAS CHANGED ITS NAME TO PETROLEUM OPERATIONS SUSTAINMENT TRAINING (POST). POST WILL CONTINUE TO PROVIDE HANDS ON COMPREHENSIVE INLAND PETROLEUM DISTRIBUTION SYSTEM (IPDS) AND PETROLEUM QUALITY ANALYSIS (PQAS-E) TRAINING FOR THE ARMY AND JOINT FORCES COVERING FUEL OPERATIONS UNDER ALL CONDITIONS. POST DELIVERS IN-DEPTH, REALISTIC, AND DETAILED IPDS TRAINING AVAILABLE TO LAND-BASED FORCES WITHIN THE DEPARTMENT OF DEFENSE AND NATO ALLIES. THE TRAINING PROGRAM PROVIDES A FIRST-CLASS EXPERIENCE THAT ALLOWS UNIT COMMANDERS TO DEVELOP THEIR TRAINING PLANS BASED ON MISSION ESSENTIAL TASK LIST ASSESSMENTS, DETERMINE LEVEL & FREQUENCY OF TECHNICAL AND TACTICAL TRAINING, AND UTILIZATION OF THE JOINT TRAINING EXERCISE MODULE TO EXTEND THEIR CONUS BASED TRAINING REQUIREMENTS.
- 4. (U) THE TRAINING COURSES THAT ARE PROVIDED WITHIN POST ARE IPDS TRAINING (92F), 92L REFRESHER TRAINING (PQAS-E), 92L INSPECTOR CERTIFICATION COURSE, PETROLEUM GROUP AND BATTALION STAFF TRAINING, QUARTERMASTER LIAISON DETACHMENT TRAINING, FUEL HANDLERS REFRESHER COURSE, FUEL SYSTEM SUPPLY POINT, AND PIPELINE CONSTRUCTION & OPERATIONS (92F AND ENGINEER MOS). ALL TRAINING CAN BE TAILORED TO MEET THE NEEDS OF THE UNIT COMMANDER AND THEIR TRAINING OBJECTIVES.

- 5. (U) RESIDENT COURSES ARE TAUGHT AT FORT BARFOOT, VA. SOME COURSES CAN BE TAUGHT AT THE UNIT'S CHOSEN LOCATION THROUGH MOBILE TECHNICAL TRAINING (MTT) TEAMS. THE NECESSARY EQUIPMENT MUST BE FULLY MISSION CAPABLE AND AVAILABLE AT THE UNIT'S LOCATION. MTT'S ARE AT NO COST TO THE UNIT, SUBJECT TO LIMITED AVAILABILITY AND WILL BE PROVIDED ON A FIRST-COME FIRST-SERVE BASIS.
- 6. (U) IT IS THE UNIT'S RESPONSIBILITY TO COORDINATE TRANSPORTATION, BILLETING, AND MEALS PRIOR TO TRAVEL FOR RESIDENT COURSES AT FORT BARFOOT.
