2. (U) APPLICABILITY: ALL OFFICERS AND ENLISTED SOLDIERS OF THE ARMY NATIONAL GUARD (ARNG) AND THE U.S. ARMY RESERVE (USAR) ON ACTIVE DUTY GREATER THAN 30 DAYS WHO NEED THEIR ORDERS EXTENDED TO COMPLETE THE DISABILITY EVALUATION SYSTEM (DES) PROCESS.

3. (U) PURPOSE: TO ANNOUNCE THE WITHDRAWAL AND INACTIVATION OF REFERENCE 1.E AND TO REITERATE THE UTILIZATION OF ESTABLISHED GUIDANCE IN ACCORDANCE WITH REFERENCE 1.C.

(U) GENERAL GUIDANCE: EFFECTIVE IMMEDIATELY, COMMANDS WILL DISCONTINUE USE AND DISTRIBUTION OF THE ABOVE REFERENCE 1.E AND COMPLY WITH THE ESTABLISHED GUIDANCE SET FORTH IN THE ABOVE REFERENCE 1.C, FOR THE PROCESSES, PROCEDURES, AND RESPONSIBILITIES TO BE FOLLOWED BY KEY STAKEHOLDERS FOR RESERVE COMPONENT SOLDIERS BEING EXTENDED ON ACTIVE DUTY TO COMPLETE THE DES PROCESS. REFERENCE 1.E WAS SUPERSEDED BY THE REVISED PUBLICATION OF REFERENCE 1.C.
