- 2. (U) THIS MESSAGE APPLIES TO ALL ARMY COMMANDS, ARMY SERVICE COMPONENT COMMANDS, AND THE UNITED STATES ARMY RESERVE.
- 2.A. (U) THE PURPOSE OF THIS MESSAGE IS TO PROVIDE CLARIFYING GUIDANCE REGARDING SEXUAL HARASSMENT/ASSAULT RESPONSE AND PREVENTION (SHARP) PROGRAM EXPEDITED TRANSFERS, EXPEDITED TRANSFERS FOR VICTIMS OF SEXUAL ASSAULT AND RELATED OFFENSES, THE 24–MONTH STABILIZATION FOR FULL-TIME MILITARY SEXUAL ASSAULT RESPONSE COORDINATORS (SARCS), SHARP VICTIM ADVOCATES (VAS), AND THE INCENTIVE PROGRAM FOR SHARP PROFESSIONALS.
- 3. (U) BACKGROUND: THIS ALARACT REINFORCES THE IMPLEMENTATION OF DEPARTMENT OF DEFENSE GUIDANCE IN ACCORDANCE WITH REFERENCE 1.B, WHICH EXPANDS EXPEDITED TRANSFER REQUEST ELIGIBILITY, PROCEDURES, RESPONSIBILITIES, AND IMPLEMENTS MANDATORY 24–MONTH STABILIZATION FOR FULL-TIME MILITARY SARCS AND SHARP VAS WHO COMPLETE THE SHARP CAREER COURSE. THIS ALARACT FURTHER PROVIDES GUIDELINES FOR THE ASSIGNMENT INCENTIVES PROGRAM FOR FULL-TIME MILITARY SARCS AND SHARP VAS WHO COMPLETE THE SHARP BASIC COURSE, (VAS) SHARP INTERMEDIATE COURSE, (SARCS).
- 4. (U) EXPEDITED TRANSFER GUIDANCE: THE INTENT OF THE EXPEDITED TRANSFER POLICY IS TO ADDRESS SITUATIONS WHERE A VICTIM FEELS SAFE BUT UNCOMFORTABLE AND TO ASSIST IN THE VICTIM'S RECOVERY BY RELOCATING THEM TO A NEW LOCATION. THE EXPEDITED TRANSFER POLICY APPLIES TO SOLDIERS AND TO THEIR ADULT FAMILY MEMBERS (18 YEARS AND OLDER) WHO ARE VICTIMS OF SEXUAL ASSAULT. U.S. ARMY HUMAN RESOURCES COMMAND (HRC) SUPPORTING PROCEDURES FOR EXPEDITED TRANSFERS ARE IN ACCORDANCE WITH REFERENCES 1.D AND 1.E.
- 4.A. (U) SOLDIERS ARE ELIGIBLE TO REQUEST EXPEDITED TRANSFERS UNDER THE FOLLOWING CONDITIONS:
- 4.A.1. (U) SOLDIERS MAY REQUEST AN EXPEDITED TRANSFER WHEN THEY ARE A VICTIM OF SEXUAL ASSAULT OR RELATED OFFENSE UNDER REFERENCE 1.G; SPECIFICALLY, ARTICLES 117A, 120, 120C, AND 130. EXPEDITED TRANSFER REQUESTS WILL BE PROCESSED IN ACCORDANCE WITH REFERENCES 1.D AND 1.E.
- 4.A.2. (U) SOLDIERS MAY REQUEST AN EXPEDITED TRANSFER ON BEHALF OF THEIR ADULT FAMILY MEMBERS IF THE FAMILY MEMBER IS A VICTIM OF SEXUAL ASSAULT THAT WAS NOT COMMITTED BY THE SOLDIER REQUESTING THE TRANSFER, HAVE FILED AN UNRESTRICTED REPORT OF SEXUAL

- ASSAULT USING A DD FORM 2910 (VICTIM REPORTING PREFERENCE STATEMENT), THE SEXUAL ASSAULT SUBJECT IS A SERVICEMEMBER OR THE SUBJECT HAS A MILITARY NEXUS, OR THE SEXUAL ASSAULT OCCURRED ON A DEPARTMENT OF DEFENSE (DOD) INSTALLATION OR FACILITY. REQUESTS FOR EXPEDITED TRANSFERS FOR ADULT FAMILY MEMBERS WILL BE PROCESSED BY HRC AS A COMPASSIONATE REQUEST IN ACCORDANCE WITH REFERENCE 1.E. THE REASONS FOR A COMPASSIONATE REASSIGNMENT ARE EXPANDED FROM RAPE TO SEXUAL ASSAULT.
- 4.A.3. (U) IN ACCORDANCE WITH REFERENCE 1.B, THE FOLLOWING GUIDANCE APPLIES TO TRANSFER OF FAMILY MEMBERS:
- 4.A.3.A. (U) THE TRANSFER WILL INCLUDE THE SOLDIER AND THE SOLDIER'S FAMILY MEMBERS SHOULD THEY DESIRE TO TRANSFER. THE SOLDIER CAN REQUEST A DELAY.
- 4.A.3.B. (U) THE FAMILY MEMBERS WILL BE TRANSFERRED EXPEDITIOUSLY AND THE SOLDIER'S TRANSFER MAY BE DELAYED BASED ON PROFESSIONAL DEVELOPMENT OR OPERATIONAL REQUIREMENTS.
- 4.A.3.C. (U) THE ARMY WILL ULTIMATELY DETERMINE WHETHER SOLDIERS WILL BE TRANSFERRED AT THE SAME TIME AS THEIR FAMILY MEMBERS.
- 4.A.3.D. (U) GUIDANCE FOR TROOP PROGRAM UNIT SOLDIERS REQUESTING EXPEDITED TRANSFERS.
- 4.A.3.E. (U) U.S. ARMY RESERVE COMMAND (USARC)—TROOP PROGRAM UNIT EXPEDITED TRANSFER REQUESTS WILL BE PROCESSED IN ACCORDANCE WITH REFERENCE 1.F. REQUESTS MUST BE ENDORSED BY THE FIRST O-5 COMMANDER OR HIGHER ON DA FORM 4651 (REQUEST FOR RESERVE COMPONENT ASSIGNMENT OR ATTACHMENT). THE FIRST MISSION SUPPORT COMMAND/EXPEDITIONARY SUPPORT COMMAND SARC WILL FORWARD SUBMISSION TO THE USARC, G-1/SHARP OFFICE FOR FINAL PROCESSING. SUBSEQUENT PROCESSING GUIDANCE WILL BE PROVIDED BY THE USARC, G-1 SHARP OFFICE.
- 4.B. (U) REQUESTING SOLDIER'S BRIGADE (BDE) COMMANDER (COLONEL/O-6) OR EQUIVALENT RESPONSIBILITIES IN SUPPORT OF EXPEDITED TRANSFER ARE AS FOLLOWS:
- 4.B.1. (U) THE REQUESTING SOLDIER'S BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT HAS THE RESPONSIBILITY TO REVIEW, APPROVE OR DISAPPROVE, AND TRACK REQUESTS FOR EXPEDITED TRANSFERS.
- 4.B.2. (U) UPON RECEIPT OF AN EXPEDITED TRANSFER REQUEST, THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT MUST INFORM THE SARC OF

THE EXPEDITED TRANSFER REQUEST.

- 4.B.3. (U) THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT WILL ASSIGN PERSONNEL WITHIN THE COMMAND TO ASSIST SOLDIERS WITH APPROVED EXPEDITED TRANSFERS WITH ANY OUT-PROCESSING REQUIRED FOR PERMANENT CHANGE OF STATION (PCS) MOVES, TO INCLUDE FACILITATING TRANSPORTATION, AS NECESSARY.
- 4.B.4. (U) THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT WILL ENSURE SOLDIERS WITH APPROVED EXPEDITED TRANSFERS RECEIVE AN EVALUATION REPORT, IF REQUIRED.
- 4.B.5. (U) THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT WILL NOTIFY THE SOLDIER OF THE REQUIREMENT FOR THE VICTIM TO HAVE A FINAL MEETING WITH THE LOSING SARC AND AN INTRODUCTION (TO BE ARRANGED BY THE LOSING SARC) WITH THE GAINING SARC UPON ARRIVAL AT THEIR NEXT DUTY STATION. THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT WILL EXPLAIN THE PURPOSE OF THE INTRODUCTION WITH THE GAINING SARC IS TO HELP THE VICTIM UNDERSTAND THE FULL RANGE OF SUPPORT OPTIONS. AT THE NEW INSTALLATION, FACILITATE APPOINTMENTS WITH MENTAL HEALTH, MEDICAL, ADVOCACY, LEGAL SERVICES, OR OTHER RESPONSE PERSONNEL; AND HELP ANSWER ANY QUESTIONS THE SOLDIER-VICTIM MAY HAVE.
- 4.B.6. (U) THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT WILL INFORM THE SOLDIER OF THE REQUIREMENT TO HAVE A MEETING WITH THE GAINING COMMANDER IF THE SOLDIER-VICTIM SEEKS CONTINUED ADVOCACY, LEGAL, OR HEALTH CARE (MENTAL HEALTH OR OTHER MEDICAL) SERVICES AT THE NEW LOCATION, OR IF THE INVESTIGATION INVOLVING THE SOLDIER-VICTIM'S REPORT IS ONGOING AT THE TIME OF THE TRANSFER.
- 4.B.7. (U) THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT WILL ENSURE THE SOLDIER IS SCHEDULED FOR A FINAL MEETING WITH THE LOSING SARC SO THAT THE LOSING SARC CAN ANSWER ANY REMAINING QUESTIONS THE VICTIM MAY HAVE ABOUT THE TRANSFER PROCESS, ENSURE THE VICTIM HAS CONTACT INFORMATION FOR RESOURCES AVAILABLE AT THE NEW LOCATION, AND TO FACILITATE ANY FURTHER SCHEDULING.
- 4.B.8. (U) BDE COMMANDERS (COLONEL/O-6) OR EQUIVALENT WILL TAKE ALL NECESSARY STEPS TO ENSURE AN EXPEDITED TRANSFER DOES NOT NEGATIVELY IMPACT A SOLDIER'S CAREER, TO THE EXTENT POSSIBLE.
- 4.B.9. (U) THE LOSING BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT WILL ENSURE THE GAINING BDE COMMANDER IS AWARE OF THE SOLDIER'S ARRIVAL TO THEIR COMMAND. THIS MAY BE DONE BY TELEPHONE, EMAIL, OR OTHER WRITTEN CORRESPONDENCE. A MEMORANDUM OF RECORD WILL BE

MAINTAINED RECORDING THE ACTION.

- 4.C. (U) ONCE NOTIFIED OF A REQUEST FOR A SHARP EXPEDITED TRANSFER RELATED TO SEXUAL ASSAULT, THE LOSING SARC'S RESPONSIBILITIES IN ACCORDANCE WITH REFERENCE 1.C ARE AS FOLLOWS:
- 4.C.1. (U) THE SARC WILL CONTACT THE REQUESTING SOLDIER-VICTIM AND INFORM THEM OF THE EXPEDITED TRANSFER PROCESS, TO INCLUDE INFORMATION ABOUT SERVICES, SUPPORT, AND THE INTRODUCTION WITH THE GAINING SARC UPON ARRIVAL AT THE NEW INSTALLATION, IF REQUEST IS APPROVED.
- 4.C.2. (U) THE SARC WILL ALSO INFORM THE REQUESTING SOLDIER-VICTIM THAT AT THE CONCLUSION OF THE INTRODUCTION WITH THE GAINING SARC, THE VICTIM MAY ELECT TO CONTINUE OR DISCONTINUE SHARP PROGRAM SERVICES. THE SARC WILL EXPLAIN TO THE VICTIM THE PURPOSE OF THE INTRODUCTION IS TO HELP THE VICTIM UNDERSTAND THE FULL RANGE OF OPTIONS AT THE NEW INSTALLATION; FACILITATE APPOINTMENTS WITH MENTAL HEALTH, MEDICAL, ADVOCACY, LEGAL SERVICES, OR OTHER RESPONSE PERSONNEL; AND HELP ANSWER ANY QUESTIONS THAT THE VICTIM MAY HAVE.
- 4.C.3. (U) IF THE REQUESTING VICTIM IS A VICTIM OF SEXUAL ASSAULT, THE SARC WILL VERIFY TO THE BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT THAT THE SOLDIER-VICTIM HAS FILED AN UNRESTRICTED REPORT USING A DD FORM 2910 AND IT HAS BEEN ENTERED INTO THE DEFENSE SEXUAL ASSAULT INCIDENT DATABASE (DSAID). IF A DD FORM 2910 IS NOT ON FILE, THE SARC WILL ASSIST THE SOLDIER-VICTIM IN FILING AN UNRESTRICTED REPORT USING A DD FORM 2910 OR REFER THE SOLDIER-VICTIM TO THE APPROPRIATE ORGANIZATION (FOR EXAMPLE, FAMILY ADVOCACY PROGRAM FOR DOMESTIC ABUSE SEXUAL ASSAULT VICTIMS). THE SARC WILL NOT PROVIDE A COPY OF THE SIGNED DD FORM 2910 TO THE COMMANDER. VERBAL CONFIRMATION TO THE COMMANDER THAT DD FORM 2910 WAS FILED IS SUFFICIENT.
- 4.C.4. (U) THE SARC WILL INFORM THE SOLDIER-VICTIM OF THE REQUIREMENT TO HAVE A MEETING WITH THE GAINING BDE COMMANDER (COLONEL/O-6) OR EQUIVALENT IF THE VICTIM SEEKS CONTINUED ADVOCACY, LEGAL, OR HEALTH CARE (MENTAL HEALTH OR OTHER MEDICAL) SERVICES AT THE NEW LOCATION, OR IF THE INVESTIGATION OR LEGAL PROCEEDINGS INVOLVING THE SOLDIER-VICTIM'S REPORT ARE ONGOING AT THE TIME OF THE TRANSFER.
- 4.C.5. (U) THE SARC WILL ANNOTATE THE EXPEDITED TRANSFER REQUEST AND DECISION IN DSAID, ENSURING ALL FIELDS ARE COMPLETED, UPON RECEIPT OF THE FINAL DECISION.

- 4.C.6. (U) THE SARC WILL ENSURE THE SAFETY ASSESSMENT IS READMINISTERED WHEN CIRCUMSTANCES RELATED TO THE REQUEST FOR AN EXPEDITED TRANSFER INDICATE THERE IS A SAFETY CONCERN, THE VICTIM FILED A COMPLAINT OF RETALIATION, OR THE VICTIM REQUESTED ASSISTANCE IN OBTAINING A MILITARY OR CIVILIAN PROTECTIVE ORDER OR TEMPORARY RESTRAINING ORDER.
- 4.C.7. (U) IF THE VICTIM DISCLOSES RETALIATION RELATED TO A NON-DOMESTIC SEXUAL ASSAULT AND WANTS TO FILE AN OFFICIAL REPORT, SARCS AND SHARP VAS WILL ASSIST THE REPORTERS OF RETALIATION IN DOCUMENTING AN OFFICIAL REPORT USING DD FORM 2910–2 (RETALIATION REPORTING STATEMENT FOR UNRESTRICTED SEXUAL ASSAULT CASES).
- 4.D. (U) IN ACCORDANCE WITH REFERENCE 1.C, LOSING SARC'S RESPONSIBILITIES AFTER APPROVAL OF AN EXPEDITED TRANSFER INCLUDE—
- 4.D.1. (U) THE LOSING SARC WILL MEET WITH THE VICTIM A FINAL TIME TO ADDRESS ANY QUESTIONS ABOUT THE TRANSFER PROCESS. DURING THE MEETING THE LOSING SARC WILL INFORM THE VICTIM OF THE MEETING WITH THE BDE COMMANDER OR EQUIVALENT, AND THE INTRODUCTION WITH THE GAINING SARC WILL NOT OCCUR AT THE SAME TIME, WITHOUT THE EXPLICIT CONSENT OF THE VICTIM.
- 4.D.2. (U) THE LOSING SARC WILL INFORM THE VICTIM IN ADVANCE THAT COMMUNICATIONS WITH THE GAINING SARC AND GAINING COMMANDER IN A JOINT MEETING ARE NOT PRIVILEGED UNDER MILITARY RULE OF EVIDENCE 514 IN THE MANUAL FOR COURTS-MARTIAL.
- 4.D.3. (U) THE LOSING SARC WILL FACILITATE THE SCHEDULING OF THE INTRODUCTION WITH THE NEW SARC, TAKING INTO ACCOUNT THE VICTIM'S LEAVE (IF APPLICABLE) AND TRANSFER OR TRAVEL TIME.
- 4.D.4. (U) THE LOSING SARC WILL PROVIDE THE VICTIM WITH THE NEW SARC'S NAME AND CONTACT INFORMATION, TO INCLUDE THE ADDRESS OF THE NEW SARC'S OFFICE, AS WELL AS AN APPOINTMENT DATE AND TIME.
- 4.D.5. (U) THE LOSING SARC WILL FOLLOW EXISTING PROCEDURES TO TRANSFER THE CASE IN DSAID TO THE NEW SARC AFTER ALL INFORMATION ON THE EXPEDITED TRANSFER HAS BEEN ANNOTATED. LOSING SARCS ARE NOT REQUIRED TO OBTAIN VICTIM CONSENT TO TRANSFER THE CASE ON DD FORM 2910 AND WILL LEAVE SECTION 7, "VICTIM CONSENTED TO TRANSFER OF (RR/UR) CASE DOCUMENTS TO ANOTHER SARC," OF DD FORM 2910, BLANK. HOWEVER, LOSING SARCS WILL ENSURE THE SOLDIER-VICTIM UNDERSTANDS WHY THE CASE IS BEING TRANSFERRED IN DSAID AND THAT THE SOLDIER-

- VICTIM IS UNDER NO OBLIGATION TO CONTINUE COMMUNICATING WITH A SARC OR VA AFTER THE INTRODUCTION.
- 4.E. (U) IN ACCORDANCE WITH REFERENCE 1.C, THE LOSING SEXUAL ASSAULT REVIEW BOARD (SARB) CHAIR RESPONSIBILITIES INCLUDE—
- 4.E.1. (U) TRACK THE NUMBER OF DAYS BETWEEN THE APPROVAL DATE OF A REQUEST FOR AN EXPEDITED TRANSFER AND THE DATE THE VICTIM PHYSICALLY DEPARTS THE LOSING STATION OR THE DATE THE VICTIM CHANGES DUTY ASSIGNMENT LOCATION (PERMANENT CHANGE OF ASSIGNMENT).
- 4.E.2. (U) ALL EXPEDITED TRANSFERS TAKING LONGER THAN 30 CALENDAR DAYS MUST HAVE DOCUMENTED CIRCUMSTANCES FOR THE DELAY IN THE SARB MEETING MINUTES AND BE REPORTED TO THE SARB CHAIR, WHO MUST REVIEW THE CIRCUMSTANCES OF THE DELAY. IN ACCORDANCE WITH REFERENCE 1.A, THE SARB CHAIR WILL DIRECT A HIGH-RISK RESPONSE TEAM TO BE INITIATED WHEN CIRCUMSTANCES INDICATE THAT THE TRANSFER DELAY APPRECIABLY IMPACTS THE RISK OF HARM TO THE VICTIM.
- 4.F. (U) IN ACCORDANCE WITH REFERENCE 1.C, THE GAINING SARC RESPONSIBILITIES INCLUDE—
- 4.F.1. (U) THE GAINING SARC WILL MEET WITH THE VICTIM UPON ARRIVAL AT THE NEW LOCATION. DURING THE INTRODUCTION, THE GAINING SARC WILL EXPLAIN THE FULL RANGE OF SUPPORT OPTIONS AT THE NEW INSTALLATION; FACILITATE APPOINTMENTS WITH MENTAL HEALTH, MEDICAL, ADVOCACY, OR OTHER RESPONSE PERSONNEL; AND HELP ANSWER ANY QUESTIONS THE SOLDIER MAY HAVE. THE GAINING SARC WILL ALSO EXPLAIN THAT AFTER THE INTRODUCTION, VICTIMS MAY DECLINE ANY FURTHER SHARP SERVICES.
- 4.F.2. (U) THE GAINING SARC WILL COORDINATE WITH THE GAINING COMMANDER FOR A SEPARATE MEETING, IF REQUIRED.
- 4.F.3. (U) THE GAINING SARC WILL ENSURE THE SARB AT THE GAINING INSTALLATION REVIEWS THE VICTIM'S CASE AT THE SARB MEETING IN ACCORDANCE WITH EXISTING POLICY, DEPENDING ON WHETHER THE VICTIM SEEKS CONTINUED SERVICES OF A SARC AND/OR SHARP VA AT THE GAINING INSTALLATION AND WHETHER AN INVESTIGATION OR LEGAL PROCEEDING IS ONGOING.
- 4.F.3.A. (U) IF THE VICTIM SAYS YES TO CONTINUED ADVOCACY FROM A SARC AND/OR SHARP VA, THEN THE VICTIM'S CASE WILL BE HEARD AT THE MONTHLY SARB AT THE GAINING INSTALLATION WITH RELEVANT MEMBERS OF THE SARB FROM THE LOSING INSTALLATION CALLING IN (FOR EXAMPLE, CRIMINAL INVESTIGATION DIVISION INVESTIGATING THE SEXUAL ASSAULT AT

THE LOSING INSTALLATION WOULD CALL IN TO THE SARB MEETING AT THE GAINING INSTALLATION).

- 4.F.3.B. - 4.G.1. (U) REQUESTS FOR EXPEDITED TRANSFERS WILL BE PROCESSED IN ACCORDANCE WITH REFERENCES 1.D AND 1.E. REQUESTS MUST BE ENDORSED BY THE BATTALION (BN) COMMANDER (LIEUTENANT COLONEL/O-5) OR EQUIVALENT OR NEXT LEVEL COMMANDER ON DA FORM 4187 (PERSONNEL ACTION).
- 4.G.2. (U) REQUESTS FOR EXPEDITED TRANSFERS MUST BE APPROVED OR DISAPPROVED BY THE SOLDIER'S BN/BDE COMMANDING OFFICER WITHIN 5 CALENDAR DAYS OF THE SUBMISSION OF THE REQUEST. - 4.G.4. (U) SOLDIERS WITH APPROVED EXPEDITED TRANSFERS INVOLVING PCS MOVEMENT WILL EXECUTE THEIR PCS MOVE ONLY WHEN ELIGIBLE TO DO SO IN ACCORDANCE WITH REFERENCE 1.D OR 1.E, WHICHEVER IS APPLICABLE.
- 4.G.5. (U) BN/BDE COMMANDERS OR EQUIVALENT WHO RECOMMEND DISAPPROVAL FOR INTRA-POST TRANSFERS MUST GO TO THE GENERAL

- 4.H. (U) FOR THOSE VICTIMS NOT OTHERWISE ELIGIBLE, THE VICTIM MAY REQUEST, THROUGH THEIR COMMANDER, A COMPASSIONATE REASSIGNMENT FOR MITIGATING CIRCUMSTANCES OR FOR THE SAFETY AND WELL-BEING OF THE VICTIM.
