2. (U) THE PURPOSE OF THIS MESSAGE IS TO ANNOUNCE FORTHCOMING REVISIONS OF REFERENCES 1.A AND 1.B REGARDING THE WEAR AND APPEARANCE OF THE ARMY SERVICE UNIFORM.

3. (U) THE REVISED EDITION OF REFERENCE 1.B WILL ADD PLAIN BROADCLOTH AND POPLIN TO THE MATERIALS USED FOR THE OPTIONAL COMMERCIAL OFF-THE-SHELF SHIRT FOR MALES AND FEMALES.

4. (U) THE OPTIONAL SHIRT FOR MALES IS LONG-SLEEVED WITH BARREL CUFFS AND A STANDARD TURN-DOWN COLLAR WITH TAPERED POINTS APPROXIMATELY 2 5/8 INCHES LONG IN BRIGHT WHITE OR ARMY WHITE 521.

5. (U) THE OPTIONAL TUCK-IN OVERBLOUSE FOR FEMALES IS PLAIN COTTON BROADCLOTH OR POPLIN IN BRIGHT WHITE OR SHADE ARMY WHITE 521.

6. (U) THE REVISION WILL STILL ALLOW WEAR OF ISSUED OR COMMERCIALY PURCHASED HERRINGBONE WEAVE SHIRTS, PROVIDED THEY ARE WORN IN ACCORDANCE WITH THE SPECIFIC INSTRUCTIONS LISTED ABOVE AND IN REFERENCE 1.B.
