- 2. (U) BACKGROUND.
- 2.A. (U) COMMANDERS ARE AUTHORIZED TO CONDUCT LOCALLY DEVELOPED TRAINING TO PREPARE SOLDIERS AND CIVILIAN EMPLOYEES FOR ROUTINE AND EMERGING INSTALLATION SECURITY AND PROTECTION MISSIONS AND WILL USE ARMY LEVEL APPROVED TRAINING WHEN IT EXISTS, SUCH AS THE UNITED STATES MILITARY POLICE SCHOOL (USAMPS) TRAINING SUPPORT PACKAGE (TSP) FOR

ANTITERRORISM LEVEL 1 TRAINING. ANY LOCALLY DEVELOPED TRAINING MUST BE CONSISTENT WITH APPLICABLE ARMY AND DOD PUBLISHED STANDARDS AND APPROVED BY THE APPROPRIATE O-6 OR HIGHER COMMANDER, WITH SUPPORT FROM HIS/HER PROTECTION AND LEGAL STAFF.

- 2.B. (U) NON-STANDARD, LOCALLY DEVELOPED TRAINING PRODUCTS USED AT INSTALLATION LEVEL PERIODICALLY TO SATISFY COMMAND OR LOCAL-LEVEL TRAINING REQUIREMENTS TO FULFILL INSTALLATION SECURITY AND PROTECTION MISSION TRAINING REQUIREMENTS, THAT ARE SEPARATE OR ADDITIVE TO TRAINING REQUIREMENTS IN ARMY PROTECTION REGULATIONS, RISK CONVEYING INCORRECT INFORMATION OR FAIL TO SATISFY TRAINING REQUIREMENTS IF NOT PROPERLY REVIEWED AND APPROVED TO ENSURE CONTENT IS CORRECT AND RELEVANT PRIOR TO PRESENTATION TO TRAINING AUDIENCES. COMMANDERS WILL IDENTIFY AND REVIEW SUCH TRAINING TO ENSURE ACCURACY, RELEVANCE, AND CONSISTENCY WITH PUBLISHED ARMY, AND DOD PROTECTION-RELATED TRAINING STANDARDS, AND PROPERLY APPROVED AS PER PARAGRAPH 2.A. FOR TRAINING PRODUCTS THAT DO NOT MEET PUBLISHED TRAINING STANDARDS OR POTENTIALLY CONVEY INACCURATE INFORMATION, COMMANDERS MUST ENSURE THAT THIS TRAINING IS NOT DISSEMINATED OR PRESENTED.
- 2.C. (U) COMMANDERS WILL MAKE EVERY EFFORT TO UTLIZE A CURRENT, STANDARDIZED TRAINING SUPPORT PACKAGE (TSP) OR TRAINING LOCATED ON AN ARMY OR DOD TRAINING SITE TO MEET INSTALLATION SECURITY OR PROTECTION MISSION TRAINING REQUIREMENTS. AN EXAMPLE OF AN AUTHORIZED TSP IS THE ANTITERRORISM LEVEL I AWARENESS TRAINING SUPPORT PACKAGE, WHICH WAS DEVELOPED BY THE U.S. ARMY MILITARY POLICE SCHOOL (USAMPS) ANTITERRORISM DIVISION (AVAILABLE TO ANTITERRORISM OFFICERS AT REFERENCE 1.E.). THIS TSP MEETS ALL REQUIREMENTS FOR TERROR AWARENESS AND ANTITERRORISM BLOCKS OF INSTRUCTION FOR ARMY AUDIENCES. IN CASES IN WHICH TRAINING MUST BE TAILORED TO MEET MISSION-SPECIFIC OR UNIQUE SITUATIONAL TRAINING REQUIREMENTS, COMMANDERS WILL ENSURE THIS TRAINING IS APPROPRIATELY REVIEWED AND APPROVED AS PER PARAGRAPH 2.A. AND 2.B.
- 2.D. (U) AREA OF RESPONSIBILITY OR INSTALLATION SPECIFIC THREATS CAN BE ADDED TO INSTALLATION SECURITY OR PROTECTION MISSION TRAINING SUPPORT PACKAGES BY INSTALLATION TRAINING OFFICIALS BUT MUST BE REVIEWED AND APPROVED BY THE FIRST O-6 OR HIGHER COMMANDING OFFICER IN THE ORGANIZATION RESPONSIBLE FOR THE TRAINING. THE COMMANDER SHOULD SEEK GUIDANCE FROM THE APPROPRIATE SUPPORT STAFF AND LEGAL ADVISORS, PRIOR TO APPROVING THE TRAINING AND THE TRAINING BEING CONDUCTED.
- 2.E. (U) THE CHAIRMAN OF THE JOINT CHIEFS OF STAFF (CJCS) MAINTAINS THE DOD-SPONSORED AND CERTIFIED COMPUTER DISTANCE LEARNING INSTRUCTIONS ON REFERECE 1.G.
- 3. (U) PURPOSE. DIRECT ARMY-WIDE, INSTALLATION-LEVEL REVIEW OF ALL NON-STANDARD, LOCALLY DEVELOPED INSTALLATION SECURITY OR PROTECTION

MISSION TRAINING PRODUCTS.

- 3.A. (U) SENIOR COMMANDERS OF INSTALLATIONS WILL DIRECT AN INSTALLATION-WIDE REVIEW OF ALL GARRISON / INSTALLATION AND DIVISION-LEVEL AND ABOVE NON-STANDARD OR LOCALLY DEVELOPED INSTALLATION SECURITY OR PROTECTION MISSION TRAINING PRODUCTS CURRENTLY IN USE BY INSTALLATION TRAINING OFFICIALS. SENIOR COMMANDERS WILL DETERMINE IF THE TRAINING IS CONSISTENT WITH PUBLISHED ARMY AND DOD PROTECTION-RELATED TRAINING STANDARDS. DURING THE REVIEW PROCESS, COMMANDERS WILL ASSESS WHETHER A STANDARDIZED ARMY OR DOD-DEVELOPED TRAINING SUPPORT PACKAGE MAY BE UTILIZED TO MEET TRAINING REQUIREMENTS IN LIEU OF LOCALLY DEVELOPED TRAINING PRODUCTS, PRIOR TO THE TRAINING BEING PRESENTED TO TRAINING AUDIENCES.
- 3.B. (U) SENIOR COMMANDERS WILL ENSURE THAT ONLY OFFICIALS WHO ARE KNOWLEDGEABLE AND SCHOOL TRAINED IN THE SUBJECT MATTER BEING INSTRUCTED ARE TASKED WITH EXECUTING THE REVIEW AND ANY SUBSEQUENT INSTALLATION SECURITY OR PROTECTION MISSION TRAINING THAT OCCURS.
- 3.C. (U) SENIOR COMMANDERS OF INSTALLATIONS WILL ENSURE THAT PROCESSES AND PROCEDURES ARE IN PLACE TO ENSURE THAT THIS GUIDANCE IS BEING ADHERED TO AND TO CERTIFY THAT ANY NON-STANDARD / TAILORED INSTALLATION SECURITY OR PROTECTION MISSION TRAINING PRODUCTS IN USE AT GARRISON / INSTALLATION AND DIVISION-LEVEL AND ABOVE ARE APPROPRIATELY REVIEWED AND APPROVED BY THE FIRST O-6 OR HIGHER COMMANDER IN THE CHAIN OF COMMAND RESPONSIBLE FOR THE TRAINING, PRIOR TO THE TRAINING BEING PRESENTED TO TRAINING AUDIENCES.
- 3.D. (U) SENIOR INSTALLATION COMMANDERS WILL CERTIFY THAT ALL ORGANIZATIONS UNDER HIS/HER COMMAND ARE IN COMPLIANCE WITH THE ANTITERRORISM LEVEL I TRAINING REQUIREMENT THAT IS DISCUSSED IN PARAGRAPH 6 BELOW.
- 3.E. (U) SENIOR COMMANDERS OF INSTALLATIONS WILL REPORT COMPLETION OF REQUIREMENTS IN PARAGAPHS 3.A 3.D NOT LATER THAN 30 MARCH 2025 TO INSTALLATION OWNING COMMANDS. INSTALLATION OWNING COMMANDS WILL PROVIDE A SPREADSHEET TO POINTS OF CONTACT IDENTIFIED IN PARAGRAPH 7 THAT CERTIFIES THAT EVERY INSTALLATION UNDER THEIR COMMAND IS IN COMPLIANCE WITH PARAGRAPHS 3.A.— 3.D NOT LATER THAN 30 MARCH 2025.
- 4. (U) THE OPMG ANTITERRORISM DIVISION WILL PROVIDE UPDATED GUIDANCE IN THE NEXT PUBLICATION OF REFERENCE 1.D. PERTAINING TO THE EXECUTION OF ANTITERRORISM LEVEL I TRAINING.
- 5. (U) BEGINNING WITH THE FY26 ARMY PROTECTION PROGRAM ASSESSMENTS, THE HQDA WILL REVIEW APPLICABLE PROTECTION FUNCTIONAL AREA BENCHMARKS TO ENSURE USE OF OFFICAL TRAINING MATERIAL IF REQUIRED.
- 6. (U) HQDA ANTITERRORISM DIVISION WILL ADD A SPECIAL INTEREST ITEM TO

VALIDATE COMPLIANCE WITH THE ANTITERRORISM LEVEL I TRAINING BENCHMARK. THIS ITEM WILL AMPLIFY THE REQUIREMENT FOR ANTITERRORISM LEVEL I TRAINING TO ONLY BE CONDUCTED USING THE JOINT KNOWLEDGE ONLINE OR UNITED STATES ARMY MILITARY POLICE SCHOOL APPROVED TRAINING MODULES. COMMANDS HAVE THE AUTHORITY TO INCLUDE ADDITIONAL AREA OF OPERATION OR COMMAND SPECIFIC THREATS TO THIS TRAINING, HOWEVER THESE ADDITIONS MUST BE APPROVED IN ADVANCE BY THE FIRST O-6 OR HIGHER COMMANDING OFFICER IN THE CHAIN OF COMMAND RESPONSIBLE FOR THE TRAINING.
