(U) REFERENCE: DLA MEMORANDUM, SUBJECT DEFENSE LOGISTICS AGENCY ELECTRONIC POINT OF SALE (EPOS), 12 APRIL 2022 (AVAILABLE AT [HTTPS://ARMYEITAAS.SHAREPOINT-MIL.US/:U:/R/SITES/ASCUSAPC/SITEPAGES/REFERENCES.ASPX?CSF=1&WEB=1&E=UMOXFV](https://armyeitaas.sharepoint-mil.us/:U:/R/SITES/ASCUSAPC/SITEPAGES/REFERENCES.ASPX?CSF=1&WEB=1&E=UMOXFV)) (COMMON ACCESS CARD REQUIRED)
2. (U) PURPOSE: CONTINUE TO NOTIFY ALL UNITS/ACTIVITIES OF DEFENSE LOGISTICS AGENCY (DLA) DEPLOYMENT OF EPOS THAT BEGAN IN OCTOBER 2022. ALARACT 069/2023 HAS EXPIRED. AN EXTENSION IS NECESSARY DUE TO IMPLEMENTATION DELAYS TO FACILITATE THE COMPLETION OF THIS IMPORTANT MISSION.
3. (U) MISSION: EPOS WILL REPLACE THE EXISTING AUTOMATED FUEL SERVICE STATION PEDESTALS THAT MANAGE DEFENSE FUEL SUPPLY POINT OF SERVICE SALES. EPOS ALSO PROVIDES DLA ENERGY NEW CAPABILITIES BY ENABLING ABILITY FOR MOBILE TRANSACTIONS, DISPATCH OPERATIONS, EVIDENTIAL MATTER COLLECTION, AND CHECKLIST/DOCUMENTATION REFERENCING.
4. (U) QUICK RESPONSE (QR) CODES WILL BECOME THE PRIMARY PURCHASE MEDIA FOR ARMY TACTICAL EQUIPMENT AT INSTALLATIONS AND WILL BE AFFIXED TO EACH FUEL CONSUMING PIECE OF EQUIPMENT.
5. (U) EQUIPMENT LIST FOR QR CODES REQUEST WILL BE PULLED FROM GLOBAL COMBAT SUPPORT SYSTEM-ARMY (GCSS-ARMY) BASED UPON LINE-ITEM NUMBER (LIN) OR WILL BE DEVELOPED LOCALLY FOR NON-MODIFICATION TABLE OF ORGANIZATION AND EQUIPMENT IN GCSS-ARMY. THERE ARE TWO PRE-BUILT LINS CONSUMING EQUIPMENT LAYOUTS (QR CODE FOR BULK FUEL TANKS AND QR CODE FOR FUEL CONSUMING EQUIPMENT) TO USE FOR THE QR CODE REQUEST. THE INSTRUCTIONS FOR GCSS-ARMY REPORTS ARE INCLUDED IN THE ARMY-SPECIFIC GUIDANCE.
6. (U) THE DLA DEPLOYMENT SCHEDULE FOR ARMY INSTALLATIONS AND ACTIVITIES HAS BEEN PUBLISHED AND IS AVAILABLE ON THE U.S. ARMY PETROLEUM CENTER (USAPC) WEBSITE AT [HTTPS://USAPC.ARMY.MIL](https://usapc.army.mil).

7. (U) THE USAPC HAS PROVIDED SPECIFIC GUIDANCE FOR ARMY ACTIVITIES TO REQUEST QR CODES. THE GUIDANCE WILL BE PROVIDED AHEAD OF EACH INSTALLATION'S SCHEDULED EPOS DEPLOYMENT AND WILL BE AVAILABLE ON THE USAPC WEBSITE AT [HTTPS://USAPC.ARMY.MIL](https://usapc.army.mil).

8. (U) ALL ARMY UNITS, INSTALLATIONS, AND ACTIVITIES WILL COMPLY WITH THE INSTRUCTIONS PROVIDED BY USAPC.
