**I. GENERAL COURTS MARTIAL.**—By direction of the President, the commanding officer, Headquarters and Service Group, General Headquarters Far East Command, is empowered, pursuant to the eighth article of war, to appoint general courts martial, *effective as of 25 May 1948*.

**II. FORT ROSECRANS NATIONAL CEMETERY, CALIFORNIA.**—The following-described parcels of land designated as "North Extension" and "South Extension," now a part of the Fort Rosecrans Military Reservation, California, are hereby made a part of the Fort Rosecrans National Cemetery, California, and placed under the jurisdiction of The Quartermaster General:

**North Extension.**—Beginning at a 2-inch iron pipe set at the northwest corner of the existing Fort Rosecrans National Cemetery, said northwest corner being in the easterly line of California State Highway No. 12 (Catalina Boulevard) 80 feet wide; thence along the easterly line of said highway N. 2°52'15" W. 322.37 feet to the beginning of a tangent curve, concave to the west, having a radius of 2,040 feet; thence along said curve through a central angle of 5°43'45" an arc distance of 203.95 feet; thence, tangent to said curve, N. 8°36'00" W. 524.45 feet to a concrete monument set in said easterly line of said highway; thence, leaving said easterly line, N. 38°28'50" E. 440.04 feet; thence S. 61°28'20" E. 215.16 feet; thence S. 1°34'30" W. 210.44 feet; thence S. 55°25'30" E. 53.00 feet; thence S. 4°34'30" W. 311.97 feet; thence S. 39°24'50" W. 397.96 feet; thence S. 1°05'30" E. 481.54 feet to a point in the boundary of said existing National Cemetery; thence along said boundary N. 20°57'45" W. 74.92 feet; thence continuing along said boundary S. 87°07'45" W. 80.00 feet to the point of beginning.

The parcel of land described contains 8.88 acres, more or less.

**South Extension.**—Beginning at the southwest corner of said existing National Cemetery, said southwest corner being a point in the said easterly line of said State Highway; thence along the south boundary line of said existing National Cemetery N. 87°07'31" E. 191.00 feet; thence, leaving said south boundary line, N. 67°37'10" E. 200.10 feet; thence S. 22°46'33" E. 638.00 feet; thence S. 18°50'47" W. 203.00 feet; thence S. 39°36'37" W. 162.28 feet; thence S. 73°45'58" W. 157.00 feet; thence S. 4°30'31" E. 222.97 feet; thence S. 85°40'30" W. 214.14 feet to a 2-inch iron pipe set in said easterly highway line; thence along said easterly highway line N. 4°19'30" W. 1,162.03 feet to the point of beginning.

The parcel of land described contains 11.70 acres, more or less.

Bearings for the foregoing descriptions are based on rectangular coordinate system with origin at U. S. C. and G. S. Station "Old Town."
