I. INDUSTRIAL MOBILIZATION PLANNING FIELD UNIT.—*Effective as of 1 May 1948*, the Industrial Mobilization Planning Field Unit, established at the Columbus General Distribution Depot, U. S. Army, Columbus, Ohio, by section I, General Orders 21, Department of the Army, 1947, was redesignated as the Transportation Corps Industrial Mobilization Planning Office, a class II activity under the control of the Chief of Transportation.

II. SECTION 55C, NATIONAL DEFENSE ACT, UNIT.—*Effective immediately*, so much of section III, General Orders 22, Department of the Army, 1948, as pertains to St. John's High School, Delphos, Ohio, is rescinded.

III. WAC TRAINING CENTER.—*Effective as of 15 June 1948*, a WAC Training Center was established at Camp Lee, Virginia, as a class I activity under the control of the Commanding General, Second Army.

IV. MERITORIOUS UNIT COMMENDATION.—By direction of the Secretary of the Army, under the provisions of paragraph 14, AR 200-15, the Meritorious Unit Commendation is awarded to the following unit of the Army of the United States for exceptionally meritorious conduct in the performance of outstanding service during the period indicated. The citation reads as follows:

The 29th Medical Depot Company is commended for exceptionally meritorious service from 15 October 1945 to 15 September 1946. In accomplishing their assigned mission, the personnel of this unit planned, established, and operated a medical depot which furnished a large proportion of all medical supplies to troops located in Japan and Korea. In addition to normal depot operations, this unit received and processed medical equipment from inactivated units in the Sixth and Eighth Army occupational areas. From 15 March to 15 September 1946, 13,195 tons of excess and surplus property was handled. Through its outstanding service and high standards of discipline, the 29th Medical Depot Company did much to reflect credit on itself and the Army of the United States.
