1..NATIONAL MEMORIAL CEMETERY OF THE PACIFIC.—Effective as of 1 October 1948, the following-described tract of land, now a part of the Punchbowl Military Reservation, Honolulu, Territory of Hawaii, was placed under the jurisdiction of The Quartermaster General and established as the National Memorial Cemetery of the Pacific:

A tract of land situated at Kewalo and Auwaiolimu, Honolulu, Territory of Hawaii, more particularly described as follows:

Beginning at concrete monument No. 1 on the southerly boundary of this tract of land, at the east corner of Alapai Street and at the north corner of Grant 7535, the coordinates of said point of beginning referred to Government Survey Triangulation Station "Punchbowl" being 964.85 feet south and 162.84 feet east, thence running by azimuths measured clockwise from true south: (1) 127°10'00" 177.60 feet along Alapai Street, along Land Court Application 591 to concrete monument No. 2; (2) 175°34'10" 129.08 feet along Land Court Application 591 to concrete monument No. 3; (3) 60°20'30" 164.98 feet along Land Court Application 591 to the easterly side of Prospect Street, passing over concrete monument No. 4 at 160.90 feet; thence along Prospect Street on a curve to the left with a radius of 500.00 feet, the direct azimuth and distance being: (4) 165°24'23" 75.34 feet; thence along same on a curve to the left with a radius of 500.00 feet, the direct azimuth and distance being: (5) 156°36'04" 78.19 feet; (6) 152°07'00" 268.32 feet along same: thence along same on a curve to the right with a radius of 750.00 feet, the direct azimuth and distance being: (7) 169°35'30" 450.44 feet; (8) 187°04′00′′ 503.59 feet along Prospect Street, passing over concrete monument No. 7.6 at 120.28 feet; thence along same on a curve to the right with a radius of 683.17 feet, the direct azimuth and distance being: (9) 191°37'15" 108.49 feet; thence along same on a curve to the right with a radius of 1,200.00 feet, the direct azimuth and distance being: (10) 198°30'32" 97.73 feet; (11) 315°24'00" 546.20 feet along Lot 1, Block 31, of the Auwalolimu Lots, along Governor's Executive Order 726 (National Guard of Hawaii Reservation) to concrete monument No. 18, passing over concrete monument No. 17 at 29.88 feet; (12) 315°15′00′′ 1,451.00 feet along Governor's Executive Order 726 (National Guard of Hawaii Reservation) to concrete monument No. 19; (13) 347°21'40" 205.07 feet along same to concrete monument No. 20; (14) 44°40'00" 129.00 feet along Grants 8088 and 8084 to concrete monument No. 21; (15) 43°43'00" 86.00 feet along Grant 6719 to concrete monument No. 22; (16) 67°31'00" 131.60 feet along Grant 9266 to concrete monument No. 23; (17) 43°35′00′′ 142.50 feet along Grant 9085 to concrete monument No. 24; (18) 111°11'00'' 689.60 feet along Grants 11253, 11182, 9060, 9023, 8885, Land Court Application 1238, and Grant 7535, to the point of beginning, and containing an area of 34.222/acres, more or less.

II.-PUERTO RICO NATIONAL CEMETERY.—Effective as of 1 October 1948, the following-described land transferred from the Department of the Navy to the Department of the Army for the site of a national cemetery, having been AGO 644B—Oct. 800539°—48

acquired by the Department of the Navy under Condemnation Proceedings, Civil No. 3247, titled "U. S. of America, Petitioner v. 99.95 acres of land, more or less, in the Ward of Hato Tejas, Municipality of Bayamon, Puerto Rico, Central Juanita, Incorporated, et al., Defendants" and Civil No. 3385, titled "U. S. of America, Petitioner v. 8.29 acres of land, more or less, in the Ward of Hato Tejas, Municipality of Bayamon, Puerto Rico, Central Juanita, Incorporated, et al., Defendants," both suits having been filed in the District Court of the United States for Puerto Rico, was placed under the jurisdiction of The Quartermaster General and established as the Puerto Rico National Cemetery:

1. A parcel of land in the Ward of Hato Tejas, Municipality of Bayamon, Puerto Rico, containing an area of 8.29 acres, shown on P. W. Drawing No. 1039 of the Tenth Naval District, entitled "Property Map, Machine Gun Range Bayamon, P. R." approved 30 November 1942, filed with the above-cited Condemnation Proceeding, Civil 3385, and described by metes and bounds as follows:

Beginning at point No. 18, as shown on said drawing, which is a stake by a fence post on the easterly line of the Punta Brava Road at its intersection with the boundary line between land of Juan Martino and land of Central Juanita Inc., thence from said point of beginning and following along said boundary line between land of Juan Martino and land of Central Juanita Inc., N. 75°33'08" E., a distance of 565.77 feet to point No. 3, which is a concrete monument; thence, departing from the boundary line between land of Juan Martino and land of Central Juanita Inc., and following the boundary between land of said Central Juanita Inc., and land of the United States, the following courses and distances: S. 20°17'40" W., a distance of 303.03 feet to a point indicated as "Blanco," which is a concrete monument; thence S. 14°43'58" W., a distance of 575.34 feet to a point No. 17, which is a concrete monument; thence N. 75°15'36" W., a distance of 522.44 feet to point No. 16, which is a concrete monument on the easterly line of the Punta Brava Road; thence along the easterly line of the Punta Brava Road, N. 20°13'38" E., a distance of 603.80 feet to point No. 18, which is the point of beginning.

Boundary description—rural.—Parcel of land situated in the Ward of Hato Tejas, Municipality of Bayamon, Puerto Rico, consisting of 8.29 acres, equal to 8.54 cuerdas, equivalent to 3 hectares, 35 ares and 66 centiares, bounded; on the north, by land of Juan Martino; on the east and on the south by land of the United States, formerly of Central Juanita Inc., and on the west by the Punta Brava Road which separates the parcel herein described from other lands of Central Juanita Inc.

2. A parcel of land in the Ward of Hato Tejas, Municipality of Bayamon, Puerto Rico, containing an area of 99.95 acres, shown as parcels No. 1 and No. 2 on P. W. Drawing No. 1039 of the Tenth Naval District entitled "Property Map Machine Gun Range, Bayamon, P. R.," approved 30 November 1942, filed with the above-cited Condemnation Proceeding, Civil No. 3247, and described by metes and bounds as follows:

Beginning at a concrete monument shown as point No. 13 on said P. W. Drawing No. 1039, which point is on the easterly line of the Punta Brava Road at its intersection with the northerly line of land of Otto Irizarry: thence from said point of beginning and following along the easterly line of said Punta Brava road, the following courses and distances: N. 27°36′17″ E., a distance of 904.83 feet to point No. 14, which is a mango tree; thence N. 24°54′26″ E., a distance of 215.93 feet to point No. 15, which is a mango tree: thence N. 20°32′31″ E., a

distance of 428.79 feet to point No. 16, which is a concrete monument: thence departing from the easterly line of said Punta Brava Road, S. 75°15'36" E. a distance of 522.44 feet to point No. 17, which is a concrete monument; thence N. 14°43'58" E., a distance of 575.34 feet to a point indicated as "blanco," which is a concrete monument; thence N. 20°17'40" E., a distance of 303.03 feet to point No. 3, which is a concrete monument on the southerly line of land of Juan Martino; thence along said southerly line, the following courses and distances: N. 79°37'34" E., a distance of 613.64 feet to point No. 10, which is a concrete monument; thence N. 89°20'09" E., a distance of 438.35 feet to point No. 4; thence S. 84°03'51" E., a distance of 192.24 feet to point No. 5; thence S. 76°45'57" E., a distance of 472.55 feet to point No. 6, which is an iron pipe at the northeasterly corner of land of Central Juanita, Inc., which is shown as parcel No. 1: thence traversing land of Juan Martino, S. 32°58'35" E., a distance of 601.02 feet to a palm tree which marks a point on the boundary between said land of Juan Martino and other land of Central Juanita, Inc.; thence along the boundary between said land of Juan Martino and land of Central Juanita, Inc., S. 37°01'52" W., a distance of 1,718.27 feet to a point at the top of a rock cliff, which point is locally known as Santa Catalina point and marks the southerly corner of land of Juan Martino and is a common point on the boundary between lands of Central Juanita, Inc. and Otto Irizarry; thence along the boundary between said lands, the following courses and distances: N. 41°14'17" W., a distance of 124.05 feet to a point indicated as "Y"; thence S. 87° 32'11" W., a distance of 1,465.25 feet to point No. 9, which is a concrete monument; thence S. 73°48'34" W., a distance of 892.48 feet to point No. 13, which is the point of beginning.

Boundary description—rural.—Parcel of land situated in the Ward of Hato Tejas, Municipality of Bayamon, Puerto Rico, consisting of 99.95 acres, equivalent to 102.91 cuerdas, equivalent to 40 hectares, 44 ares, 84 centiares, bounded on the north by land of Central Juanita, Inc., and land of Juan Martino; on the east by land of Central Juanita, Inc.; on the south by land of Otto Irizarry; and on the west by the Punta Brava Road, which crosses land of Central Juanita, Inc., and land of Central Juanita, Inc., and land of Central Juanita, Inc.
