I. AUDIT OF NONAPPROPRIATED FUNDS.—1. Responsibility for the audit of nonappropriated funds is assigned to the Comptroller of the Army in accordance with section 402(b), title IV (Public Law 216—81st Cong.), approved 10 August 1940.

2. Staff and technical supervision over the audit of nonappropriated funds, except those joint funds administered under joint departmental policies, will be exercised by the Comptroller of the Army. Such supervision includes responsibility for prescribing audit policies and procedures; determining audit standards; review and action on reports of audit procedures and standards, recommendations, and other correspondence relative to the audit of nonappropriated funds; review of accounting systems; field surveys; and maintenance of liaison with other departmental agencies relative to the audit of these funds.

3. Operational performance of audits will continue as prescribed in current regulations.

II. TERRITORIAL COMMAND TEST, THIRD ARMY AREA.—1. Termination.—Effective as of 1 November 1948, Territorial Command Test, Third Army Area, was terminated. Command of units, activities, and installations listed in DA General Orders 42, 1948, as amended, reverts to heads of appropriate administrative or technical services or other Department of the Army agencies.
