**I. GENERAL COURTS MARTIAL.**—By direction of the President, the commanding officers of the following commands are empowered, pursuant to AW 8, to appoint general courts martial, *effective 15 August 1950*.

1. Camp Atterbury, Indiana.
2. Camp Cooke, California.
3. Camp Pickett, Virginia.
4. Camp Polk, Louisiana.

**II. ANTI-AIRCRAFT ARTILLERY AND FIELD ARTILLERY REPLACEMENT TRAINING CENTERS.**—1. *Effective 10 August 1950*, an Antiaircraft Artillery Replacement Training Center is established as a class I activity at Fort Bliss, Texas, a class I installation under the jurisdiction of the Commanding General, Fourth Army.

2. *Effective 10 August 1950*, a Field Artillery Replacement Training Center is established as a class I activity at Fort Sill, Oklahoma, a class I installation under the jurisdiction of the Commanding General, Fourth Army.

**III. CLEVELAND TANK PLANT, OHIO.**—*Effective 15 August 1950*, the Cleveland Tank Plant, Ohio, is established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

**IV. INSTALLATIONS.**—1. *Effective 1 August 1950*, the following installations are returned to active status:

- a. Camp Atterbury, Indiana, a class I installation under the jurisdiction of the Commanding General, Fifth Army.
- b. Camp Chaffee, Arkansas, a class I installation under the jurisdiction of the Commanding General, Fourth Army.
- c. Camp Cooke, California, a class I installation under the jurisdiction of the Commanding General, Sixth Army.
- d. Camp Pickett, Virginia, a class I installation under the jurisdiction of the Commanding General, Second Army.
- e. Camp Polk, Louisiana, a class I installation under the jurisdiction of the Commanding General, Fourth Army.
- f. Fort Leonard Wood, Missouri, a class I installation under the jurisdiction of the Commanding General, Fifth Army.

*b.* Rocky Mountain Arsenal, Denver, Colorado, a class II industrial installation under the jurisdiction of the Chief Chemical Officer.

*2. Effective 9 August 1950, the following installations are returned to active status:*

*a.* Camp Edwards, Massachusetts, a class I installation under the jurisdiction of the Commanding General, First Army.

*c.* Camp Roberts, California, a class I installation under the jurisdiction of the Commanding General, Sixth Army.

*d.* Camp Rucker, Alabama, a class I installation under the jurisdiction of the Commanding General, Third Army.

*e.* Camp Stewart, Georgia, a class I installation under the jurisdiction of the Commanding General, Third Army.

**V. MILITARY TRAINING UNIT, ST. ANTHONY'S HIGH SCHOOL, LONG BEACH, CALIFORNIA.**—Effective 30 June 1950, the military training unit at St. Anthony's High School, Long Beach, California, established under the provisions of section 55c, National Defense Act, is withdrawn.

**VI. NAMED GENERAL HOSPITALS.**—Effective immediately, named general hospitals are redesignated as follows:

*3.* Valley Forge Army Hospital, Phoenixville, Pennsylvania.

**VII. REPLACEMENT TRAINING CENTERS.**—*1. Effective 21 August 1950, a Chemical Replacement Training Center is established as a class II activity at the Army Chemical Center, Maryland, a class II installation under the jurisdiction of the Chief Chemical Officer.*

*2. Effective 23 August 1950, an Engineer Replacement Training Center is established as a class II activity at the Engineer Center, Fort Belvoir, Virginia, a class II installation under the jurisdiction of the Chief of Engineers.*

*3. Effective 21 August 1950, an Ordnance Replacement Training Center is established as a class II activity at Aberdeen Proving Ground, Maryland, a class II installation under the jurisdiction of the Chief of Ordnance.*

*4. Effective 22 August 1950, a Medical Replacement Training Center is established as an activity of Brooke Army Medical Center, a class II activity under the jurisdiction of The Surgeon General, located at Fort Sam Houston, Texas, a class I installation under the jurisdiction of the Commanding General, Fourth Army.*

*5. Effective 25 August 1950, a Quartermaster Replacement Training Center is established as a class II activity at the Quartermaster Center, Fort Lee, Virginia, a class II installation under the jurisdiction of The Quartermaster General.*

*6. Effective 21 August 1950, a Transportation Corps Replacement Training Center is established as a class II activity at Fort Eustis, Virginia, a class II installation under the jurisdiction of the Chief of Transportation Corps.*

**VIII. STOCKTON SUBDEPOT OF BENICIA ARSENAL, CALIFORNIA.—**  
*Effective 1 September 1950*, the Stockton Ordnance Subdepot, California, a class II installation under the jurisdiction of the Chief of Ordnance is transferred to the control of The Quartermaster General and redesignated as part of Sharpe General Depot, California, a class II installation under the jurisdiction of The Quartermaster General.

**IX. TRANSPORTATION CORPS CENTER, FORT EUSTIS, VIRGINIA.—**  
*Effective 21 August 1950*, the Transportation Corps Center is established at Fort Eustis, Virginia, as a class II activity under the jurisdiction of the Chief of Transportation Corps and consists of the following activities:

1. Transportation Corps School.
  2. Transportation Corps Replacement Training Center.
  3. Transportation Corps Board.
  4. Transportation Research and Development Station.
  5. All Transportation Corps units stationed at Fort Eustis, Virginia.
