- I..ENLISTED PERSONNEL.—1. Pursuant to section 4, 1951 Amendments to the Universal Military Training and Service Act (Title I, PL 51, 82d Cong; DA Eul. 12, 1951), the period of active service of the following categories of enlisted personnel who were serving on active duty on 19 June 1951 pursuant to the provisions, as indicated, of the Universal Military Training and Service Act (formerly the Selective Service Act of 1948), as amended, is increased accustive months, unless such persons are sooner released, transferred, or discharged and unless the period of service of such persons has otherwise been increased or extended:
  - a. Those inducted pursuant to subsection 4 (a);
  - b. Those enlisted in the Regular Army pursuant to subsection 4 (c) (1);
- c. Those members of the Reserve components of the Army of the United States ordered to active duty upon their own applications pursuant to subsection 4 (c) (2);
- d. Those members of the Reserve components of the Army of the United States ordered to active duty with or without their consent, whether as individuals or as members of units, pursuant to section 21.
- Nothing in the foregoing will be construed as altering any special programs
  for release of civilian components personnel, nor will it affect the release of
  those reservists ordered to active military service for 1 year with their consent.

Effective 1 July 1951, the Transportation Corps Central Procurement Agency is established as a class II activity, under the jurisdiction of the Chief of Transportation, at the Marietta Transportation Corps Depot, Pennsylvania, a class II installation under the jurisdiction of the Chief of Transportation.
