MERITORIOUS UNIT COMMENDATION—Awards	II

I..CAMP WELLFLEET, SOUTH WELLFLEET, MASSACHUSETTS.—Effective 1 November 1951, Camp Wellfleet, South Wellfleet, Massachusetts, is designated a class I subinstallation of Camp Edwards, Massachusetts, a class I installation under the jurisdiction of the Commanding General, First Army.

II..MERITORIOUS UNIT COMMENDATION.—By direction of the Secretary of the Army, under AR 280-15, the Meritorious Unit Commendation is awarded to the following units of the United States Army for exceptionally meritorious conduct in the performance of outstanding service during the periods indicated. The citations read as follows:

1. The *62d Engineer Construction Battalion* is cited for exceptionally meritorious conduct in the performance of outstanding service in Korea in support of combat operations during the period 25 September 1950 to 31 May 1951. During this period, the battalion was charged with many difficult missions of a greatly varied nature. These tasks included repair, construction, and maintenance of many miles of main supply routes vital to successful military operations. Both temporary and permanent highway and railroad bridges also were rebuilt or constructed. Although hampered by a critical shortage of equipment and personnel, all technical and constructional problems assigned to the battalion were accomplished on or ahead of schedule. The *62d Engineer Construction Battalion* displayed such outstanding devotion and superior performance of exceptionally difficult tasks as to set it apart and above other units with similar missions. The high degree of skill, morale, discipline, and willingness with which members of the *62d Engineer Construction Battalion* performed the tasks allotted them reflect great credit on themselves, the Corps of Engineers, and the military service of the United States. 2. The *Medical Company, 187th Airborne Infantry Regiment*, is cited for exceptionally meritorious conduct in the performance of outstanding service in Korea in support of combat operations during the period 24 September 1950 to 31 May 1951. The *Medical Company* operated with unusual efficiency under extremely difficult and trying conditions in furnishing medical support for the 187th Airborne Regimental Combat Team during this period and participated in two parachute assaults into enemy territory. Displaying extraordinary devotion to duty and superior operating ability, the *Medical Company* met all challenges and successfully accomplished its duties. The speed, efficiency, and diligence with which all tasks were performed contributed to the success of the command in battle and provided confidence that no man would suffer from lack of care or treatment. The *Medical Company* displayed such outstanding devotion and superior performance of exceptionally difficult tasks as to set it apart and above other units with similar missions. The morale, esprit de corps, discipline, and devotion to duty exhibited by the members of the *Medical Company, 187th Airborne Infantry Regiment*, typify efficiency and reflect great credit on the organization and military service of the United States. 3. The *Military Police Platoon, 187th Airborne Infantry Regiment*, is cited for exceptionally meritorious conduct in the performance of outstanding service in Korea in support of combat operations during the period 24 September 1950 to 31 May 1951. The mobility of the 187th Airborne Regimental Combat Team, which has resulted in its use in many sectors, caused the military police the heavy burden of much detailed road reconnaissance, marking routes, and acting as guides. During engagements in combat, the *Military Police Platoon* demonstrated skill in handling and processing prisoners of war, control of refugees, internal security, and traffic control. During this period, the *Military Police Platoon* participated in two parachute assaults into enemy held territory. The manner in which they performed on both occasions established their gallantry and devotion to duty. The *Military Police Platoon* displayed such outstanding devotion and superior performance of exceptionally difficult tasks as to set it apart and above other units with similar missions. The exceptionally meritorious service of the *Military Police Platoon, 187th Airborne Infantry Regiment*, reflects great credit on this unit and the military service of the United States.
