II..QUARTERMASTER TRAINING COMMAND, FORT LEE, VIRGINIA.—
1. Effective I December 1952, the Quartermaster Center, a class II activity under the jurisdiction of The Quartermaster General and located at Fort Lee, Virginia, is redesignated the Quartermaster Training Command, a class II activity under the jurisdiction of The Quartermaster General, with headquarters at Fort Lee, Virginia, and will consist of the following activities:

The Quartermaster School, Fort Lee, Virginia.

The Quartermaster Replacement Training Center, Fort Lee, Virginia.

The Quartermaster Technical Training Service, Fort Lee, Virginia.

All quartermaster troop units stationed at Fort Lee, Virginia.

- 2. Effective 1 December 1952, the Quartermaster Board, an activity of the Quartermaster Center at Fort Lee, Virginia, is redesignated a quartermaster class II activity under the jurisdiction of The Quartermaster General, with station at Fort Lee, Virginia.
- 3. Effective 1 March 1953, the following quartermaster activities and/or troop units are placed under the jurisdiction of the Quartermaster Training Command:
  - a. The Quartermaster Subsistence School, Chicago, Illinois.
- b. All quartermaster troop units located within the continental United States and assigned to The Quartermaster General by Department of the Army orders.
  - 4. Section III, DA General Orders 33, 1948, is rescinded.
