I. ARMY AVIATION SCHOOL, FORT SILL, OKLAHOMA.—Effective 1 January 1953, the Army Aviation School is established at Fort Sill, Oklahoma, as a class I activity under the jurisdiction of the Commanding General, Fourth Army.

II. CAMP EDWARDS, MASSACHUSETTS.—Effective 1 February 1953, Camp Edwards, Massachusetts, a class I installation under the jurisdiction of the Commanding General, First Army, is placed in an inactive status.

III. CAMP WELLFLEET, SOUTH WELLFLEET, MASSACHUSETTS.—Effective 1 February 1953, Camp Wellfleet, South Wellfleet, Massachusetts, is designated a class I subinstallation of Fort Devens, Massachusetts, a class I installation under the jurisdiction of the Commanding General, First Army.
