1. Recommended lists.—The approved recommended lists of officers of the Judge Advocate General's and Chaplains promotion lists, selected in accordance with section 509, Officer Personnel Act of 1947 (61 Stat. 894; 10 U. S. C., Supp. V, 559c), for promotion to the permanent grades of lieutenant colonel, major, and captain, Regular Army, are announced in the order of their seniority. All officers named in this lists will be nominated for promotion at the appropriate time and, upon appointment in the higher grade, will rank in permanent grade in the seniority sequence in which their names appear in paragraph 3.

2. Physical examinations required for promotion.—All officers listed in paragraph 3 are required to take a physical examination in order to qualify for promotion (par. 9, AR 40-100). Reports of physical examinations prepared on Standard Form 88 (Report of Medical Examination) will be forwarded to The Surgeon General, Department of the Army, Washington 25, D. C., ATTN: MEDDP, as soon as completed, and in any event in time to reach that office not later than 20 March 1953. The forwarding communication will state specifically that the report is furnished in connection with promotion in the Regular Army.
