For the defense of the Imiin River and Hantan River line from 18 April 1951 to 28 April 1951; for the strategic retrograde from 24 April to 2 May 1951; and for the defense of Seoul from 3 May 1951 to 11 May 1951, inclusive. Having driven north to the Imfin and Hantan Rivers, the 3d Infantry Division, controlling all the major arteries to Seoul, became the prime target of the powerful Chinese Communist spring offensive. In the face of the overwhelming and frenzied hostlle numbers, the 3d Infantry Division held tenaciously, inflicting untold casualties and irretrievably disrupting the enemy plans. Then, displaying great gallantry, a high degree of tactical ability, and unshakeable devotion to its cause, the 3d Infantry Division effected a brilliant deliberate retrograde with devastating effect upon the enemy. Finally, at the approaches to Seoul the division once more held courageously to dissipate the last hostile thrusts and to deny to the enemy the vital city. The individual and collective heroism of each member of the 3d Infantry Division was conspicuous and is in accord with the highest traditions of the military service.
