I. ARMED FORCES EXAMINING STATIONS.—1. *Effective 1 July 1953*, the Armed Forces Examining Station at Denver, Colorado, is discontinued as an element of the United States Navy Main Recruiting Station and redesignated an element of the United States Marine Corps Recruiting Station.

2. *Effective 1 July 1953*, the Armed Forces Examining Station at Omaha, Nebraska, is discontinued as an element of the United States Army—United States Air Force Recruiting Main Station and redesignated an element of the United States Navy Main Recruiting Station.
