I..GODMAN ARMY AIR FIELD, FORT KNOX, KENTUCKY.—Effective 1 May 1954, Godman Air Force Base is redesignated Godman Army Air Field and made a part of Fort Knox, Kentucky, a class I installation under the jurisdiction of the Commanding General, Second Army.

II..LOS ANGELES REGIONAL OFFICE OF THE SIGNAL CORPS SUPPLY AGENCY, LOS ANGELES, CALIFORNIA.—Effective 30 June 1954 the Los Angeles Regional Office of the Signal Corps Supply Agency, Los Angeles, California, a class II activity under the jurisdiction of the Chief Signal Office, is discontinued.

III..ORDNANCE TEST STATION, YUMA, ARIZONA.—Effective 1 April 1954, the Ordnance Test Station is established as a class II activity, in an active status, under the jurisdiction of the Chief of Ordnance, at Yuma Test Station, Arizona, a class I installation under the jurisdiction of the Commanding General, Sixth Army.

IV..UNITED STATES ARMY REHABILITATION TRAINING CENTER, CAMP GORDON, GEORGIA.—Effective 31 March 1954, the Camp Gordon Rehabilitation Training Center, a class I activity, located at Camp Gordon, Georgia, is redesignated the United States Army Rehabilitation Training Center, a class I activity, under the jurisdiction of the Commanding General, Third Army.
