I...ARMY SUPPLY MANAGEMENT COURSE, FORT LEE, VIRGINIA.—Effective 1 July 1954, the Army Supply Management Course is established at Fort Lee, Virginia, as a class II activity under the jurisdiction of The Quartermaster General.

2. The Chief of Transportation will continue to furnish administrative support to the Oversea Supply Agency, New York, in accordance with the provisions of AR 10-730.

2. DA General Orders 33, 1953, as amended by paragraph 3, section IV, DA General Orders 60, 1953, pertaining to the award of the Republic of Korea Presidential Unit Citation to the 2d Logistical Command (G), is further amended as follows:

Add: 151st Engineer Combat Battalion.

3. So much of DA General Orders 10, 1954, pertaining to the award of the Republic of Korea Presidential Unit Citation to The Second United States Infantry Division (2d Award) as reads "The intervention, on 25 November 1951, of the Chinese Communists" is amended to read "The intervention, on 25 November 1950, of the Chinese Communists."
