- 1. Recommended lists.—The approved recommended lists of officers of the Women's Army Corps promotion list, selected in accordance with sections 509 and 509a, Officer Personnel Act of 1947 (61 Stat. 894; 62 Stat. 358; 10 U. S. C. 559c, 559c-1), for promotion to the permanent grades of lieutenant colonel and major, Regular Army, are announced in the order of their seniority. All officers named in these lists will be nominated for promotion at the appropriate time and, upon appointment in the higher grade, will rank in permanent grade in the seniority sequence in which their names appear in paragraph 3.
- 2. Physical examinations required for promotion.—All officers listed in paragraph 3 are required to take a physical examination or to submit a certificate in lieu thereof in order to qualify for promotion (see par. 9, AR 40-100). Report of physical examination prepared on Standard Form 88 (Report of Medical Examination) or a certificate, prepared in accordance with paragraph 9b, AR 40-100, to the effect that a final-type physical examination has been accomplished within 1 year will be forwarded to The Surgeon General, Department of the Army, Washington 25, D. C., ATTN: MEDDP-IA, as soon as completed and in time to reach that office not later than 1 August 1954. The forwarding communication will state specifically that the report is furnished in connection with promotion in the Regular Army.
