LEGION OF MERIT.—1. By direction of the President, under the act of Congress approved 20 July 1942 (sec. III, WD Bul. 40, 1942) and Executive Order 9260, 29 October 1942 (sec. I, WD Bul. 54, 1942), the Legion of Merit, in the Degree of Commander, for exceptionally meritorious conduct in the performance of outstanding service is awarded to the following-named officer:

Lieutenant General *Jesus Miranda Vargas*, Philippine Armed Forces.

2. By direction of the President, under the act of Congress approved 20 July 1942 (sec. III, WD Bul. 40, 1942) and Executive Order 9260, 29 October 1942 (sec. I, WD Bul. 54, 1942), the Legion of Merit, in the Degree of Commander, for exceptionally meritorious conduct in the performance of outstanding service during the period indicated is awarded to the following-named officer:

Major General *Kim Yong Bae*, Republic of Korea Army. 30 May 1952 to 15 March 1953.

Major General *Mom Choa Jitjanok Kritakara*, Royal Thai Army. 20 August 1953 to 30 April 1954.

Brigadier General *Kim Ung Soo*, Republic of Korea Army. 1 May to 29 November 1953.

Lieutenant Colonel *Woldeyohannes Shitta*, Infantry, Ethiopian Army. 16 April 1953 to 31 March 1954.

Brigadier General *Paik Hong Suk*, Republic of Korea Army. 13 August 1952 to 2 July 1953.

Lieutenant Colonel *Parti Yosakrai*, Infantry, Royal Thailand Army. 5 June 1953 to 15 January 1954.
