III..SIGNAL SUPPLY SECTION, NEW CUMBERLAND GENERAL DEPOT, U. S. ARMY, NEW CUMBERLAND, PENNSYLVANIA.—*Effective 1 July 1954*, the Signal Supply Section of New Cumberland General Depot, U. S.
