I..CAMP RUCKER, ALABAMA.—Section VII, DA General Orders 56, 1953, pertaining to inactivation of Camp Rucker, Alabama, is rescinded.

II...COMMAND MANAGEMENT SCHOOL, FORT BELVOIR, VIRGINIA.—

III. ARMORED CENTER, FORT KNOX, KENTUCKY.—Effective 1 July 1954, the Armored Center, located at Fort Knox, Kentucky, is designated a class I activity under the jurisdiction of the Commanding General, Second Army. IV.-ANTIAIRCRAFT AND GUIDED MISSILE CENTER, FORT BLISS, TEXAS.—Effective 1 July 1954, the Antiaircraft and Guided Missile Center, located at Fort Bliss, Texas, is designated a class I activity under the jurisdiction of the Commanding General, Fourth Army. The Antiaircraft and Guided Missile Center will consist of all units and activities located at Fort Bliss with exception of Army Field Forces Board Number 4 and the Office of the Special Weapons Development Director.

The Artillery Center will consist of all units and activities located at Fort Sill except Army Field Forces Board Number 1.

VIII..FINANCE AND ACCOUNTS OFFICE, UNITED STATES ARMY, WASHINGTON, D. C.—1. Effective 1 August 1954 the Finance Accounts Office, U. S. Army, Washington, D. C., and the Finance Office, U. S. Army, Washington, D. C., class II activities under jurisdiction of the Chief of Finance are consolidated. The consolidated office is designated the Finance and Accounts Office, U. S. Army, a class II activity under jurisdiction of the Chief of Finance.

2. The Finance and Accounts Office, U. S. Army will continue to perform the functions of the two former activities.
