1. **Recommended lists.**—The approved recommended lists of officers of the Judge Advocate General's Corps, selected in accordance with the provisions of Public Law 614, 83d Congress (sec. XIX, DA Bul 11, 1954), approved 21 August 1954 for promotion to the permanent grades of colonel, lieutenant colonel, major, and captain, Regular Army, are announced in the order of their seniority. Upon appointment in the higher grade they will rank in permanent grade in the seniority sequence in which their names appear in paragraph 3, and will be integrated in their proper position on the Army Promotion List.

2. **Physical examinations required for promotion.**—All officers listed in paragraph 3 are required to take a physical examination in order to qualify for promotion. Report of physical examination prepared on Standard Form 88 (Report of Medical Examination), or a certificate to the effect that a final type physical examination has been accomplished within 1 year, prepared in accordance with paragraph 9b, AR 40-100, will be forwarded to The Surgeon General, Department of the Army, Washington 25, D. C., ATTN: MEDDP-IA, at the earliest practical date. The forwarding communication will state specifically that the report is furnished in connection with promotion in the Regular Army.
