I..ARMY MAINTENANCE BOARD, FORT KNOX, KENTUCKY. *Effective 1 April 1955*, the Army Maintenance Board is established as a class II activity, under the jurisdiction of the Deputy Chief of Staff for Logistics, Department of the Army, at Fort Knox, Kentucky, a class I installation under the jurisdiction of the Commanding General, Second Army.

II..CAMP GORDON REPLACEMENT TRAINING CENTER, CAMP GORDON, GEORGIA. *Effective 12 November 1954*, the Camp Gordon Replacement Training Center is discontinued as a class I activity at Camp Gordon, Georgia, a class I installation under the jurisdiction of the Commanding General, Third Army.

III..CORAOPOLIS ORDNANCE STEEL FOUNDRY, CORAOPOLIS, PENNSYLVANIA. *Effective 1 March 1955*, the government-owned facility formerly designated as the Continental Foundry and Machine Company, Coraopolis, Pennsylvania, is redesignated the Coraopolis Ordnance Steel Foundry, Coraopolis, Pennsylvania, and established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

IV..EAST CHICAGO ORDNANCE STEEL FOUNDRY, EAST CHICAGO, INDIANA. *Effective 1 March 1955*, the government-owned facility formerly designated as the American Steel Foundries, East Chicago, Indiana, is redesignated the East Chicago Ordnance Steel Foundry, East Chicago, Indiana, and established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

V..LENAPE ORDNANCE MODIFICATION CENTER, NEWARK, DELAWARE. *Effective 1 March 1955*, the government-owned facility formerly designated as the Tank Modification Plant, Newark, Delaware, is redesignated the Lenape Ordnance Modification Center, Newark, Delaware, and established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

VI..LIMA ORDNANCE STEEL FOUNDRY, LIMA, OHIO. *Effective 1 March 1955*, the government-owned facility formerly designated as the Ohio Steel Foundry, Lima, Ohio, is redesignated the Lima Ordnance Steel Foundry, Lima, OHIO 4241B—Mar. 310485*—55

Ohio, and established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

VII..MELVINDALE ORDNANCE FORGE PLANT, DETROIT, MICHIGAN. *Effective 1 March 1955*, the government-owned facility formerly designated as the Timkin-Detroit Axle Company, Detroit, Michigan, is redesignated the Melvindale Ordnance Forge Plant, Detroit, Michigan, and established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

VIII..NISKAYUNA ORDNANCE MODIFICATION PLANT, SCHENECTADY, NEW YORK. *Effective 1 March 1955*, the Niskayuna Ordnance Modification Plant, Schenectady, New York, is established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

IX..OGDEN ORDNANCE PLANT, UTAH. *Effective 31 March 1955*, the Ogden Ordnance Plant, Utah (formerly Ogden Arsenal), a class II installation under the jurisdiction of the Chief of Ordnance, is discontinued.

X..PACIFIC ORDNANCE STEEL FOUNDRY, PITTSBURG, CALIFORNIA. *Effective 1 March 1955*, the government-owned facility formerly designated as the Columbia Steel Foundry, Pittsburg, California, is redesignated the Pacific Ordnance Steel Foundry, Pittsburg, California, and established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

XI..SCRANTON ORDNANCE PLANT, SCRANTON, PENNSYLVANIA. *Effective 1 March 1955*, Scranton Ordnance Plant, Scranton, Pennsylvania, is established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.

XII..ST. LOUIS ORDNANCE STEEL FOUNDRY, ST. LOUIS, MISSOURI. *Effective 1 March 1955*, the government-owned facility formerly designated as the Scullin Steel Company, St. Louis, Missouri, is redesignated the St. Louis Ordnance Steel Foundry, St. Louis, Missouri, and established as a class II industrial installation under the jurisdiction of the Chief of Ordnance.
