S. Army, St. Louis, Missouri, a class II activity under the jurisdiction of the Chief of Transportation.

V..TRANSPORTATION CORPS MOVEMENT CONTROL OFFICE, SIGNAL CORPS SUPPLY AGENCY, PHILADELPHIA, PENNSYLVANIA. *Effective 1 August 1955*, the Transportation Corps Movement Control Office, a class II activity, under the jurisdiction of the Chief of Transportation, located at the Signal Corps Supply Agency, Philadelphia, Pennsylvania, a class II activity under the jurisdiction of the Chief Signal Officer, is redesignated the Transportation Field Movement Office, an activity of the First Transportation Zone, U. S. Army, Pittsburgh, Pennsylvania, a class II activity under the jurisdiction of the Chief of Transportation.

VI..TRANSPORTATION CORPS MOVEMENT CONTROL OFFICE, ROCK ISLAND ARSENAL, ILLINOIS. *Effective 1 July 1955*, the Transportation Corps Movement Control Office, a class II activity, under the jurisdiction of the Chief of Transportation, located at the Ordnance Weapons Command, Rock Island Arsenal, Illinois, a class II installation under the jurisdiction of the Chief of Ordnance, is redesignated the Transportation Field Movement Office, an activity of the Third Transportation Zone, U. S. Army, St. Louis, Missouri, a class II activity under the jurisdiction of the Chief of Transportation.

VII..TRANSPORTATION CORPS MOVEMENT CONTROL OFFICE, REDSTONE ARSENAL, ALABAMA. *Effective 1 July 1955*, the Transportation Corps Movement Control Office, a class II activity, under the jurisdiction of the Chief of Transportation, located at Redstone Arsenal, Alabama, a class III installation under the jurisdiction of the Chief of Ordnance, is redesignated the Transportation Field Movement Office, an activity of the Second Transportation Zone, U. S. Army, Memphis, Tennessee, a class II activity under the jurisdiction of the Chief of Transportation.
