I..RIO VISTA ARMY TERMINAL, RIO VISTA, CALIFORNIA. *Effective 15 February 1956*, the Rio Vista Army Terminal, Rio Vista, California, a class II installation under the jurisdiction of the Chief of Transportation, and assigned to the Pacific Transportation Terminal Command, is redesignated the Rio Vista Storage Area, a class II installation under the jurisdiction of the Chief of Transportation, and assigned to the Transportation Supply and Maintenance Command, St. Louis, Missouri.

II..RIO VISTA STORAGE ACTIVITY, RIO VISTA, CALIFORNIA. *Effective 15 February 1956*, the Rio Vista Storage Activity, Rio Vista, California, a class II activity under the jurisdiction of the Chief of Transportation, assigned to the Pacific Transportation Terminal Command, and designated as a class II storage activity of the Sharpe General Depot, is redesignated a class II storage activity, under the jurisdiction of the Chief of Transportation, with location at the Rio Vista Storage Area, and is assigned to the Transportation Supply and Maintenance Command, St. Louis, Missouri.

III..BEAVER STORAGE ACTIVITY, CLATSKANIE, OREGON. *Effective 15 February 1956*, the Beaver Storage Activity, Clatskanie, Oregon, a class II activity under the jurisdiction of the Chief of Transportation, assigned to the Pacific Transportation Terminal Command, and designated as a class II storage activity of the Sharpe General Depot, is redesignated a class II storage activity under the jurisdiction of the Chief of Transportation, with location at the Beaver Army Terminal, and is assigned to the Transportation Supply and Maintenance Command, St. Louis, Missouri.

IV..DELTA STORAGE ACTIVITY, LOUISIANA. *Effective 15 February 1956*, the Delta Storage Activity, Louisiana, a class II activity under the jurisdiction of the Chief of Transportation, assigned to the Gulf Transportation Terminal Command and designated as a class II storage activity of the Charleston Transportation Depot, is redesignated as a class II storage activity under the jurisdiction of the Chief of Transportation, and is assigned to the Transportation Supply and Maintenance Command, St. Louis, Missouri.

V..TANK CAR REGULATING OFFICE, HOUSTON, TEXAS. *Effective 1 April 1956*, the Tank Car Regulating Office, a class II activity under the jurisdiction of the Chief of Transportation, located at Houston, Texas, is discontinued and its functions transferred to the Headquarters, Third Transportation Zone, St. Louis, Missouri.
