I..GENERAL COURTS-MARTIAL. The Chief, Military Assistance Advisory Group, Taiwan, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22a (6), MCM, 1951, to convene general courts-martial, *effective 1 November 1955.*

II..CLEVELAND TANK PLANT, CLEVELAND, OHIO. *Effective 1 March 1956,* the Cleveland Tank Plant, Cleveland, Ohio, a class II industrial installation under the jurisdiction of the Chief of Ordnance, is redesignated the Cleveland Ordnance Plant.

III..SIGNAL CORPS SUPPLY AGENCY, PHILADELPHIA, PENNSYLVANIA. *Effective 1 March 1956,* the Signal Corps Supply Agency, Philadelphia, Pennsylvania, a class II activity under the jurisdiction of the Chief Signal Officer, is redesignated as the Army Signal Supply Agency.

IV..CHICAGO REGIONAL OFFICE, SIGNAL CORPS SUPPLY AGENCY. *Effective 1 March 1956,* the Chicago Regional Office, Signal Corps Supply Agency, is redesignated the Chicago Regional Office, Army Signal Supply Agency.

V..LAS VEGAS HIGH SCHOOL, LAS VEGAS, NEVADA. *Effective 31 January 1956,* the 55c unit previously established at Las Vegas High School is redesignated as a multiple school, military training unit under the provisions of section 55c, National Defense Act, as amended, for the Las Vegas Union School District, Las Vegas, Nevada. The following schools are authorized to participate in the 55c program:
