**I..MILITARY SUBSISTENCE SUPPLY AGENCY, CHICAGO, ILLINOIS.** *Effective 1 July 1956*, the Military Subsistence Supply Agency is established as a class II activity under the jurisdiction of The Quartermaster General, with headquarters at 226 West Jackson Boulevard, Chicago 6, Illinois.

**II..MILITARY TRAFFIC MANAGEMENT AGENCY, WASHINGTON, D. C.** *Effective 1 July 1956*, the Military Traffic Management Agency is established as a class II activity under the jurisdiction of the Chief of Transportation with headquarters at Washington, D. C.

**III..TRANSPORTATION AIRCRAFT TEST AND SUPPORT ACTIVITY, FORT RUCKER, ALABAMA.** *Effective 1 July 1956*, the Transportation Aircraft Test and Support Activity is established as a class II activity under the jurisdiction of the Chief of Transportation, at Fort Rucker, Alabama, a class I installation under the jurisdiction of the Commanding General, Third Army, and is assigned to the Transportation Supply and Maintenance Command.

**IV..TRANSPORTATION FIELD MOVEMENT OFFICE, ST. LOUIS, MISSOURI.** *Effective 30 June 1956*, the Transportation Field Movement Office, an activity of the Third Transportation Zone, U. S. Army, St. Louis, Missouri, a class II activity under the jurisdiction of the Chief of Transportation, and located at the Engineer Supply Control Office, St. Louis, Missouri, a class II activity under the jurisdiction of the Chief of Engineers, is discontinued.

**V..KANSAS ORDNANCE PLANT, PARSONS, KANSAS.** *Effective 1 June 1956*, the Kansas Ordnance Plant, Parsons, Kansas, a class II industrial installation under the jurisdiction of the Chief of Ordnance, is placed in an active status.
