I. LEGION OF MERIT. By direction of the President, under the provisions of the act of Congress approved 20 July 1942 (sec. III, WD Bul. 40, 1942) and Executive Order 10600, 15 March 1955 (sec. I, DA Bul. 3, 7 April 1955), the Legion of Merit for exceptionally meritorious conduct in the performance of outstanding service during the period indicated is awarded to the following-named officer:

Chief Warrant Officer, W2, *Silas B. Bowling*, , Transportation Corps, United States Army. 26 March 1953 to 11 October 1955.

II. LEGION OF MERIT. By direction of the President, under the provisions of the act of Congress approved 20 July 1942 (sec. III, WD, Bul. 40, 1942) and Executive Order 10600, 15 March 1955 (sec. I, DA Bul. 3, 7 April 1955), the Legion of Merit, in the Degree of Legionnaire, for exceptionally meritorious conduct in the performance of outstanding service during the period indicated is awarded to the following-named officer.

Colonel *Armando Silva Rojas*, Army of Peru. 8 November 1954 to 17 February 1956.

III. COMMENDATION RIBBON WITH METAL PENDANT. 1. By direction of the Secretary of the Army, under the provisions of paragraph 20, AR 600-45, the Commendation Ribbon with Metal Pendant for meritorious service during the periods indicated is awarded to the following-named officers and enlisted man:

3. By direction of the Secretary of the Army, under the provisions of paragraph 20, AR 600-45, the Commendation Ribbon with Metal Pendant (first Oak Leaf Cluster), for meritorious achievement on the date indicated is awarded to the following-named enlisted man:

Master Sergeant *Jerome A. Schneider*, , then First Sergeant, Artillery, United States Army. 17 December 1945.
