**I..SPECIAL COURTS-MARTIAL.** The Commanding Officer, Headquarters and Headquarters Company, Special Troops, Headquarters, United States Army, Europe (7890th) is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 23(a)(7), to convene special courts-martial, *effective 1 October 1956.*

**II..ARMED FORCES MEDICAL LIBRARY, WASHINGTON, D. C.** *Effective 30 September 1956,* the Armed Forces Medical Library, a joint agency of the three Military Departments, subject to the authority, direction, and control of the Secretary of Defense and under the management control of the Secretary of the Army, is discontinued.

**III..JOINT CONEX CONTROL AGENCY, WASHINGTON, D. C.** *Effective 15 September 1956,* the Joint CONEX (Container Express) Control Agency is established as a class II activity under the jurisdiction of the Chief of Transportation, with location in Washington, D. C.

**IV..TRANSPORTATION RESEARCH AND DEVELOPMENT COMMAND, FORT EUSTIS, VIRGINIA.** *Effective 1 October 1956,* the Transportation Research and Development Command (TRADCOM), a class II activity under the jurisdiction of the Chief of Transportation, located at Fort Eustis, Virginia, is redesignated the Transportation Research and Engineering Command (TRECOM).
