I..GENERAL COURTS-MARTIAL. The commanding officer of the following command in United States Army, Europe, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 20 October 1956*:

IV..ARMED FORCES EXAMINING STATION, SAN FRANCISCO, CALIFORNIA. *Effective 1 November 1956*, the Armed Forces Examining Station, San Francisco, California, established by section II, DA General Orders 75, 1951, and DA General Orders 51, 1954, is relocated at Oakland, California.
