**I..PSYCHOLOGICAL WARFARE CENTER, FORT BRAGG, NORTH CAROLINA.** So much of section IV, General Orders 37, 1952, as reads "Psychological Warfare Center" is amended to read "Special Warfare Center."

**II..PSYCHOLOGICAL WARFARE SCHOOL, PSYCHOLOGICAL CENTER, FORT BRAGG, NORTH CAROLINA.** So much of section IV, General Orders 92, 1952, as reads "Psychological Warfare School is established as an activity of the Psychological Warfare Center" is amended to read "Special Warfare School is established as an activity of the Special Warfare Center."

**III..EDWARD GARY AIR FORCE BASE, TEXAS.** *Effective 15 December 1956*, Edward Gary Air Force Base, Texas, is transferred from the control of the Department of the Air Force to the Department of the Army, and designated Camp Gary, Texas, a class I installation under the jurisdiction of the Commanding General, Fourth Army. The airfield located at Camp Gary is designated Gary Army Air Field.

**IV..PHILLIPS FIELD, ABERDEEN PROVING GROUND, MARYLAND.** *Effective 10 October 1956*, Phillips Field, located at Aberdeen Proving Ground, Maryland, is redesignated Phillips Army Air Field.

**V..FINANCE OFFICE, U. S. ARMY, CAIRO, EGYPT.** *Effective 30 November 1956*, the Finance Office, U. S. Army, Cairo, Egypt, a class II activity under the jurisdiction of the Chief of Finance, is discontinued and its functions assigned to Commander in Chief, United States Army, Europe.

**VI..ROTC UNIT, WISCONSIN STATE COLLEGE.** *Effective at the beginning of the 1956-1957 academic year*, the ROTC unit at Wisconsin State College is redesignated the University of Wisconsin, Milwaukee, ROTC Unit.
