MILITARY TRAFFIC MANAGEMENT AGENCY

1. *Effective 1 February 1957*, the Eastern Traffic Region is established with headquarters at Pittsburgh, Pennsylvania, and a branch office in the greater New York (New York) area, as an activity of the Military Traffic Management Agency, a class II activity under the jurisdiction of the Chief of Transportation. The Eastern Traffic Region will consist of the States of Connecticut, Delaware, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, and the District of Columbia.

2. *Effective 1 February 1957*, the Southeastern Traffic Region is established with headquarters at Atlanta, Georgia, as an activity of the Military Traffic Management Agency, a class II activity under the jurisdiction of the Chief of Transportation. The Southeastern Traffic Region will consist of the States of Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, Tennessee, Virginia, and West Virginia.

3. *Effective 1 February 1957*, the Central Traffic Region is established with headquarters at St. Louis, Missouri, and a branch office in the greater Chicago (Illinois) area, as an activity of the Military Traffic Management Agency, a class II activity under the jurisdiction of the Chief of Transportation. The Central Traffic Region will consist of the States of Colorado, Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Montana, Nebraska, North Dakota, Ohio, South Dakota, Wisconsin, and Wyoming.

4. *Effective 1 February 1957*, the Southwestern Traffic Region is established with headquarters at Dallas, Texas, as an activity of the Military Traffic Management Agency, a class II activity under the jurisdiction of the Chief of Transportation. The Southwestern Traffic Region will consist of the States of Arkansas, Louisiana, New Mexico, Oklahoma, and Texas.

5. *Effective 1 February 1957*, the Western Traffic Region is established with headquarters at San Francisco, California, and a branch office in the greater Los Angeles (California) area, as an activity of the Military Traffic Management Agency, a class II activity under the jurisdiction of the Chief of Transportation. The Western Traffic Region will consist of the States of Arizona, California, Idaho, Nevada, Oregon, Utah, and Washington.
