**I..GENERAL COURTS-MARTIAL.** So much of section I, DA General Orders 1, 1957, as reads "United States Army Communications Zone, Advance Section," is changed to read "United States Army Communications Zone, Advance Section, Verdun," and so much as reads "United States Army Communications Zone, Base Section" is changed to read "United States Army Communications Zone, Base Section, Poitiers."

**II..SPECIAL COURTS-MARTIAL.** The Commanding Officer, Headquarters and Headquarters Company, Special Troops, Headquarters, United States Army, Europe, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 23(a) (7), to convene special courts-martial, effective 1 January 1957.

**III..U. S. ARMY COMBAT SURVEILLANCE AGENCY, WASHINGTON, D. C.** Effective 15 January 1957, the U. S. Army Combat Surveillance Agency, Washington, D. C., is established as a class II activity under the jurisdiction of the Chief Signal Officer.

**IV..UNITED STATES ARMY MILITARY ACADEMY PREPARATORY SCHOOL.** Effective 1 July 1957, the United States Military Academy Preparatory School, a class II activity under the jurisdiction of the Superintendent, United States Military Academy, is discontinued at Stewart Air Force Base, Newburgh, New York, and is concurrently reestablished as a class II activity, under the jurisdiction of the Chief of Engineers, at Fort Belvoir, Virginia, a class III installation under the jurisdiction of the Chief of Engineers.
