I. GENERAL COURTS-MARTIAL. The Commanding Officer, United States Army Port of Embarkation, Bremerhaven, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial effective 1 March 1957.
