**I..GENERAL COURTS-MARTIAL.** The Commanding Officer, United States Army, Japan, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22 (a) (6), to convene general courts-martial *effective 1 July 1957*.

**II..DESIGNATION AND REDESIGNATION OF CHEMICAL CORPS ACTIVITIES.** 1. *Effective 1 July 1957*, the U. S. Army Chemical Corps Desert Test Activity is designated as a class II activity, under the command of the Commanding Officer, Dugway Proving Ground, Utah, with station at Yuma Test Station, Arizona. The U. S. Army Chemical Corps Desert Test Activity is attached to Yuma Test Station for logistical and administrative support as provided in AR 705-28.

2. *Effective 1 July 1957*, the U. S. Army Chemical Corps Tropic Test Activity is designated as a class II activity, under the command of the Commanding Officer, Dugway Proving Ground, Utah. The U. S. Army Chemical Corps Tropic Test Activity is attached to the U. S. Army, Caribbean for logistical and administrative support.

3. *Effective 1 July 1957*, the U. S. Army Chemical Corps Arctic Test Team, a class II activity under the command of the Commanding Officer, Dugway Proving Ground, Utah, with station at Fort Greely, Alaska, is redesignated the U. S. Army Chemical Corps Arctic Test Activity.

**III..McCORNACK ARMY HOSPITAL, PASADENA, CALIFORNIA.**

1. *Effective 1 July 1957*, the name McCornack Army Hospital is withdrawn from the installation located at 95 South Grand Avenue, Pasadena, California.

2. *Effective 1 July 1957*, the installation formerly known as McCornack Army Hospital, a class II installation under the jurisdiction of The Surgeon General, is redesignated the Pasadena Area Support Center, a class I subinstallation of Fort MacArthur, California, a class I installation under the jurisdiction of the Commanding General, Sixth United States Army.
