I. GENERAL COURTS-MARTIAL. The Commandant, Branch United States Disciplinary Barracks, Lompoc, California, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22 (a) (6), to convene general courts-martial *effective 20 September 1957*.
