I..GENERAL COURTS-MARTIAL. The Commanding Officer, Fort Polk, Louisiana, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22 (a) (6), to convene general courts-martial effective 13 December 1957.

II..GENERAL COURTS-MARTIAL. The following persons under the jurisdiction of the Department of the Army who are subject to the Uniform Code of Military Justice are attached to the Military District of Washington, U. S. Army, for all matters pertaining to the administration of military justice, including general court-martial jurisdiction, regardless of whether the installations or activities at which such persons are stationed or with which they are on duty are under the command of the Commanding Officer, Military District of Washington, U. S. Army:

1. Department of the Army personnel stationed within the geographic area of the Military District of Washington, U. S. Army, and not under the command of any other officer authorized to convene general courts-martial.

2. Department of the Army attaché personnel and Department of the Army personnel attached to attaché offices for administrative support and services.

3. Department of the Army personnel assigned to the National Advisory Committee for Aeronautics.

III..BRANCH UNITED STATES DISCIPLINARY BARRACKS, FORT CROWDER, MISSOURI. Effective 31 January 1958, the Branch United States Disciplinary Barracks, Fort Crowder, Missouri, a class I activity under the jurisdiction of the Commanding General, Fifth United States Army, is discontinued.

IV..FORT CROWDER, MISSOURI. Effective 31 January 1958, Fort Crowder, Missouri, a class I installation under the jurisdiction of the Commanding General, Fifth United States Army, is placed in an inactive status.

V..MAYNARD ORDNANCE TEST STATION, MASSACHUSETTS. Effective 16 December 1957, the Maynard Ordnance Test Station, Massachusetts, a class II industrial installation under the jurisdiction of the Chief of Ordnance, is redesignated the Maynard Quartermaster Test Activity, a class II command subinstallation of the Quartermaster Research and Engineering Center, Massachusetts, a class II installation under the jurisdiction of The Quartermaster General.
