**I.—U. S. SIGNAL COMMUNICATIONS ENGINEERING AGENCY, ARLINGTON HALL STATION, ARLINGTON 12, VA.** *Effective 14 April 1958*, the U. S. Army Signal Communications Engineering Agency, a class II activity under the jurisdiction of the Chief Signal Communications Engineering Agency, is relocated at Arlington Hall Station, Arlington 12, Virginia.

The Owensboro High Schools ROTC unit is no longer designated as a multiple unit.
