I..DISTINGUISHED SERVICE MEDAL. By direction of the President, under the provisions of the act of Congress approved 9 July 1918, the Distinguished Service Medal (first Oak Leaf Cluster) for exceptionally meritorious and distinguished service in positions of great responsibility is awarded to:

IV..SOLDIER'S MEDAL. By direction of the President, under the provisions of the act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded posthumously to:

Specialist Third Class *William H. Britt*, United States Army, distinguished himself by an act of heroism at the risk of his own life in the vicinity of Afton, Oklahoma, on 30 May 1958. While traveling on Highway 60-66-69, en route to Fort Monmouth, New Jersey, he stopped to offer assistance to the victims of an accident involving a motor vehicle which had left the highway and knocked down a pole supporting electric power transmission lines, and came to a halt at the bottom of an embankment. Although realizing the danger of the fallen electric power lines, Specialist *Britt* disregarded his personal safety to assist the victims of the accident from the wrecked and burning automobile. While rendering such assistance, he came in contact with the power lines and was electrocuted. Specialist *Britt's* courageous action, fast thinking and heroic sacrifice saved the life of at least one of the accident victims, and reflect the highest credit upon himself, and are in keeping with the honored traditions of the military service.

V..SOLDIER'S MEDAL. By direction of the President, under the provisions of the act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Master Sergeant *Ivon M. Abney*, United States Army, Company
C, 1st Battalion, United States Army Infantry Center Troop Command, Fort
Benning, Georgia, distinguished himself by heroism on 18 March 1958. While en
route to his home from Fort Benning, Sergeant *Abney* observed a car veer off the

road into a ditch and start to burn. He immediately rushed to the scene and saw an officer lying unconscious in the vehicle which by this time was burning furiously. As the injured officer could not be reached from the door, Sergeant *Abney* bravely and at the risk of his own life, promptly entered the vehicle and moved the injured officer to the door where others could carry him away to safety. This immediate and courageous action by Sergeant *Abney* in complete disregard of his own personal safety undoubtedly prevented the loss of the injured officer's life, reflecting great credit upon himself and the military service.

Sergeant First Class *Edwin J. Berg*, Artillery, United States Army, Battery B, 436th Antiaircraft Artillery Missile Battalion (NIKE-AJAX) (C), distinguished himself by heroism near Travis Air Force Base, California, on 3 June 1958. While proceeding to his battery area, Sergeant *Berg*, with another soldier, observed a United States Air Force C-124 aircraft crash near the road, break up, and burst into flames. Running immediately to the scene of the crash, Sergeant *Berg* and his companion removed to a safe place an injured airman who had emerged from the tail section and collapsed in burning gasoline on the ground. Working quickly, Sergeant *Berg* returned to the burning wreckage and locating another unconscious airman, removed him from the danger area with the assistance of a serviceman who joined the rescue operation. Sergeant *Berg's* heroic action and unselfish disregard for his own personal safety saved the lives of the two airmen, reflecting great credit upon himself and the military service.

Master Sergeant *David K. Broad*, Corps of Engineers, United States Army, a member of Company D, 65th Engineer Battalion (Infantry Division), distinguished himself by heroism in Lale, Oahu, Territory of Hawaii on 7 June 1958. While parking his automobile, Sergeant *Broad* noticed flames coming from the vicinity of the kitchen of a neighbor's house approximately 500 yards from his own dwelling and drove immediately to the burning house to investigate. Upon peering through a dense blanket of smoke, he noticed two or more small forms on the floor. He attempted to open the door and discovered that it was locked from the inside. Without hesitation and with complete disregard for his own personal safety, he broke open the locked door of the building and, despite the risk of being trapped and burned to death, delivered five sleeping children who were located in various rooms of the house to safety. Sergeant *Broad's* decisive action and exceptional courage in the face of grave danger undoubtedly saved the lives of these children, reflecting the utmost credit upon himself and the military service.

Private First Class *Kenneth E. Gillenwater*, Artillery, United States Army, Howitzer Company, 2d Battalion, 2d Armored Cavalry Regiment, distinguished himself by heroism at Bamberg, Germany in the City Bahnhof (railroad station), on 1 April 1958. While performing duty as one of two guards for vehicles rail loaded for shipment, Private *Gillenwater* noticed a bright flash of light, and upon investigation found a fellow soldier in flames as a result of contact with overhead high voltage lines on top of one of the vehicles. With complete disregard for his own personal safety and in the face of imminent danger of contact with the high voltage lines himself, Private *Gillenwater* climbed on top of the vehicle and extinguished the flames on the injured man. Despite the dangerous proximity of the overhead lines and possibility of personal injury in attempting to lower the body of a man heavier than himself, he managed to lower the victim from a distance of seven feet. Private *Gillenwater's* prompt, courageous action and presence of mind, demonstrated by risking his life in

this extremely hazardous situation, reflect the utmost credit upon himself and the military service.

Sergeant *Forrest O. James*, Artillery, United States Army, Battery B, 436th Antiaircraft Artillery Missile Battalion (NIKE-JAX) (O), distinguished himself by heroism near Travis Air Force Base, California, on 3 June 1958. While proceeding to his battery area, Sergeant *James*, with another soldier observed a United States Air Force C-124 aircraft crash near the road, break up, and burst into flames. Running immediately to the scene of the crash, Sergeant *James* and his companion removed to a safe place an injured airman who had emerged from the tail section and collapsed in burning gasoline. Sergeant *James* remained with the injured airman and rendered first aid until he was evacuated. Sergeant *James'* heroic action and unselfish disregard for his own personal safety saved the life of the airman, reflecting great credit upon himself and the military service.
