I..DISTINGUISHED SERVICE MEDAL. By direction of the President, under the provisions of the act of Congress approved 9 July 1918, the Distinguished Service Medal (First Oak Leaf Cluster) for exceptionally meritorious and distinguished service in a position of great responsibility is awarded to:

Major General *Paul D. Adams*, , United States Army. 26 July to 25 October 1958.

Major General *Halley G. Maddow*, , United States Army. 1 September 1950 to 31 January 1959. (This award supersedes the award of the Legion of Merit (Second Oak Leaf Cluster), for service from 3 August 1953 to 27 July 1954, as published in General Orders Number 28, Headquarters, United States Army Forces, Far East and Eighth United States Army, 25 January 1955.)

II..LEGION OF MERIT. 1. By direction of the President, under the provisions of the act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Colonel *Maynard N. Levenick*, , Infantry, United States Army. April 1946 to 15 January 1959.

III..SOLDIER'S MEDAL. By direction of the President, under the provisions of the act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Private *Elbert S. Burkes*, , Artillery, United States Army, Battery C, 6th Missile Battalion (NIKE-AJAX), 6th Artillery Regiment, distinguished himself by heroism at Pittsburgh, Pa., on 22 August 1958. Observing smoke and flames emanating from the top floor of a two and one-half story frame dwelling, Private *Burkes* immediately rushed across the street to a neighboring house, aroused the occupants and instructed them to summon the fire department. Without hesitation or concern for his own personal safety, he entered the flaming building, awoke two occupants on the first floor and proceeded to the

second floor where he found a bedridden woman, wrapped her in his coat and carried her to safety. Despite the flames, smoke and intense heat, he entered the burning building four times and evacuated six persons, bringing from the second floor on his third trip a man unable to walk. Private *Burkes'* prompt and courageous action in the face of great danger reflects distinct credit upon himself and the military service.
