I..GENERAL COURTS-MARTIAL. The Commanding Officer, Antilles Command, United States Army Caribbean, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial *effective 15 January 1959.*

III..PERCY JONES ARMY HOSPITAL, BATTLE CREEK, MICH. *Effective 1 June 1958,* the Percy Jones Army Hospital, Battle Creek, Mich., previously inactive, was discontinued as a Department of the Army Installation.

IV..NATIONAL TUBE COMPANY, McKEESPORT, PA. *Effective 15 February 1959,* the National Tube Company, McKeesport, Pa., a class II industrial installation under the jurisdiction of the Chief of Ordnance, is discontinued as an Army Installation.
