IX..NUCLEAR WEAPON ACCIDENT INVESTIGATION BOARD (CONUS). The Nuclear Weapon Accident Investigation Board (CONUS) is established as a standing Investigation Board to investigate any Army nuclear weapon accident occurring in the CONUS. A nuclear weapon accident is an unexpected event involving a nuclear weapon or component resulting in any of the following:

c. Loss or serious damage to the weapon or component. Serious damage is damage sufficient to render a nuclear weapon or component unsafe or non-operational to an extent which requires major rework or complete replacement.

- b. Nuclear or nonnuclear detonation of the weapon.
- c. Radioactive contamination.
- d. Public hazard.

The Board investigates accidents outside the CONUS only when directed to do so by the Headquarters, Department of the Army. The Board convenes when an Army nuclear weapon accident occurs and reports findings of investigation in accordance with the provisions of AR 15-22.
